Dear Ms. Bridwell:

This letter serves as formal notice to the Kentucky Public Service Commission (“Commission”) and all parties that Nucor Steel Gallatin, LLC (“Nucor”) hereby withdraws from the November 24, 2025 Joint Stipulation and Settlement Agreement (“Joint Settlement”) pursuant to Paragraph 9 of that Joint Settlement. Accordingly, the Joint Settlement “*shall be void and withdrawn by the Parties hereto from further consideration by the Commission...*”

East Kentucky Power Cooperative (“EKPC”) originally requested a base rate increase of \$79.7 million, or 7.49%. The final Order authorized an increase of \$63.6 million, or 5.98%.

EKPC originally requested a base rate increase to Nucor of \$9.0 million, or 11%. Despite the reduced revenue requirement approved by the Commission, the final Order imposed a base rate increase on Nucor of \$15.3 million, or 18.59%. The 18.59% base rate increase to Nucor is more than three times the system average increase, contrary to the Commission’s long-standing precedent supporting gradualism in ratemaking.
