JOINT RESPONSE OF ATTORNEY GENERAL AND KIUC TO EKPC'S MOTION FOR EXTENSION OF TIME TO FILE RESPONSES TO COMMISSION STAFF'S INITIAL DATA REQUESTS; ALTERNATIVE MOTION TO MODIFY THE PROCEDURAL SCHEDULE

The Attorney General of the Commonwealth of Kentucky, through his Office of Rate Intervention ("OAG"), and the Kentucky Industrial Utility Customers ("KIUC"), also by counsel, jointly file the following Response to EKPC's Motion for a one-week extension of time to file responses to Commission Staff's Initial Data Requests, and their Alternative Motion to Modify the Procedural Schedule.

Currently, EKPC's responses are due on August 15, 2025. If the Commission grants EKPC's motion, this would work a hardship for the OAG-KIUC's consultants, who need sufficient time to review said responses prior to the due date for intervenors' initial data requests to be filed, currently scheduled for August 29, 2025. The OAG-KIUC do not object to EKPC's motion, as long as all additional steps in the procedural schedule, including the due date for intervenors' initial data requests to be filed, are also pushed back by one week. Moreover, counsel for EKPC advises they have no objection to the OAG-KIUC Alternative Motion, and authorized counsel for the OAG to represent such.

WHEREFORE, the OAG-KIUC jointly move the Commission to modify the procedural schedule in this docket by extending all remaining due dates by one week.
