On November 24, 2025, East Kentucky Power Cooperative, Inc., the Attorney General, and Nucor Steel Gallatin filed a Joint Stipulation, Settlement Agreement, and Recommendation in Case No. 2025-00208.¹ On December 2, 2025, the Commission entered an order in Case No. 2024-00402.² Based upon these factors, South Kentucky is providing an updated Attachment 1-1.
