MOTION TO SUBMIT

Comes now Farmers Rural Electric Cooperative Corporation, by and through counsel, pursuant to the August 15, 2025 Order, of the Kentucky Public Service Commission (“Commission”) and other applicable law, and moves to submit this case for an adjudication based upon the existing administrative record and without a formal evidentiary hearing, and respectfully state as follows:

1. On August 18, 2025, the Commission issued a procedural schedule in this proceeding. Farmers has filed responses to Commission Staff’s Initial Requests for Information on September 22, 2025. Farmers provided an updated response to Commission Staff’s Initial Request for Information on December 5, 2025. The August 18, 2025 Order requires the parties to request or waive a hearing on December 15, 2025. On December 8, 2025, the Commission conducted a formal hearing in Case No. 2025-00208.¹ On December 11, 2025, Farmers requested to hold the record of this proceeding open until Case No. 2025-00107 was resolved.²

2. On January 29, 2026, the Commission rendered a decision in Case No. 2025-00107.³ Contemporaneously with this Motion, Farmers is filing an updated response to Commission Staff's First Request for Information addressing the billing analysis changes based upon the Order in Case No. 2025-00107.

3. Farmers believes based upon the proceedings Case No. 2025-00208, the issues in this proceeding have been adequately addressed through the written discovery. Farmers does not believe a formal evidentiary hearing is necessary and moves to submit the case for an adjudication based upon the existing administrative record without a formal evidentiary hearing.

WHEREFORE, on the basis of the foregoing, Farmers respectfully moves to submit this case for an adjudication based upon the existing administrative record and without a formal evidentiary hearing.
