MOTION TO HOLD EVIDENTIARY RECORD OPEN

Comes now Farmers Rural Electric Cooperative Corporation, by and through counsel, pursuant to the August 15, 2025 Order, of the Kentucky Public Service Commission (“Commission”) and other applicable law, and moves to allow this case to remain open for the submission of evidence but does not request the Commission schedule a formal evidentiary hearing in this proceeding, and respectfully states as follows:

1. On August 15, 2025, the Commission issued a procedural schedule in this proceeding. Farmers has filed responses to Commission Staff’s Initial Requests for Information on September 22, 2025. Farmers provided an updated response to Commission Staff’s Initial Request for Information on December 5, 2025. The August 15, 2025 Order requires the parties to request or waive a hearing on December 15, 2025. On December 8, 2025, the Commission conducted a formal hearing in Case No. 2025-00208.¹

2. In Case No. 2025-00107,² Farmers has requested to adjust its rates for electric service. The case has been submitted for a decision by the Commission since October 17, 2025. As of the date of this filing, Farmers has not received an order approving its proposed rates for electric service. Farmers cannot request to submit this proceeding on the record until it is able to update the model provided in response to Commission Staff's First Request for Information, Item 1(a).³

3. Farmers does not believe a hearing will be necessary in this proceeding. As soon as possible after an order is issued in Case No. 2025-00107, Farmers will again update the model in this proceeding. At that point, this matter can be submitted for a decision.

WHEREFORE, on the basis of the foregoing, Farmers respectfully requests the Commission to allow this case to remain open for the submission of evidence but not schedule a formal evidentiary hearing.
