During the August 2025 monthly meeting of the Board of Commissioners of Southern Water and Sewer District the Commissioners verbally informed Mr. Randy Conley and UMG that no customer accounts shall be charged for anything that is not specifically referenced in Southern's current tariff. Southern's Commissioners intend on continuing to monitor and request clarification that no charges have/will be instituted that are not listed in the current tariff and will work to ensure that their Tariff is reasonable and up to date.
