The City of Nicholasville Water Department has seen an increase in operational costs since our last rate adjustment in 2022 and requires a wholesale rate adjustment of 15% to cover those costs. The City based this adjustment on a Cost of Service Study in it contracted in 2024.

NOTICE

Due to increased operating expenses, the Nicholasville Water Department ("Nicholasville Water") plans to file with the Public Service Commission, no later than August 1, 2025, a proposed rate schedule, to be effective September 1, 2025, to increase the volumetric and service charges for wholesale water service to Jessamine County Water District No. 1 and Jessamine-South Elkhorn Water District as follows:

The rates contained in this notice are the rates proposed by Nicholasville Water but the Public Service Commission may order rates that differ from the proposed rates.

Intervention may be requested by submitting a timely written request for intervention by mail to the Public Service Commission, Post Office Box 615, Frankfort, KY 40602. The request for intervention must establish the grounds for the request including the status and interest of the party.

If the Public Service Commission does not receive a written request for intervention within thirty (30) days of the providing of this notice, the Public Service Commission may take final action on the filing.
