Public Notice Due to a rate increase from the City of Nicholasville, notice is hereby given that Jessamine County Water District No.1 has filed an application for a Purchased Water Adjustment with the Kentucky Public Service Commission for the purpose of adjusting its water rates. Customer rates will increase by \$0.355 per 1000 gallons used. The purposed change will be effective for service rendered on or after September 15, 2025.
