**MOTION OF JOINT INTERVENORS APPALACHIAN CITIZENS' LAW
CENTER, KENTUCKIANS FOR THE COMMONWEALTH, KENTUCKY SOLAR
ENERGY SOCIETY, AND MOUNTAIN ASSOCIATION FOR LEAVE TO
DEVIATE FROM RULE**

Come now Appalachia Citizens' Law Center, Kentuckians for the Commonwealth, Kentucky Solar Energy Society, and Mountain Association (collectively "Joint Intervenors"), by and through counsel, and move for leave to deviate from the requirements of 807 KAR 5:001 Section 8. In support of their motion Joint Intervenors state as follows:

1. 807 KAR 5:001 Section 8(3) requires filings be made with the Commission via the Commission's E-Filing System at <http://psc.ky.gov>. 807 KAR 5:001 Section 8(4) requires electronic filings be made in one of several set formats. 807 KAR 5:001 Section 8(6) sets limits on the size of electronic filings. 807 KAR 5:001 Section 22 allows deviation from the rules in special cases upon good cause shown.


