Additionally, the Company notes that Tariff Pole Attachment and Tariff D.S.M. are both currently under review by the Commission in open proceedings and have been suspended pending that review (Case No. 2026-00014 and Case No. 2025-00365, respectively). Accordingly, these have not been redlined, highlighted, or annotated based on the suspended status of those tariffs.

Conversely, there are several tariffs which have been submitted to the Commission for review and have either not been suspended or are currently being implemented subject to refund in accordance with Commission orders. These tariffs consist of: Tariff U.D.C. (TFS2026-00014), Tariff E.S. (TFS2026-00024), Tariff P.P.A. (TFS2026-00036), Tariff D.R. (TFS2026-00036), and Tariff S.S.R. (TFS2026-00036). These have been redlined, highlighted, and annotated based on the version under review.
