Kentucky Power Company's Motion For Extension of Time

Kentucky Power Company (“Kentucky Power” or “Company”) respectfully moves the Public Service Commission of Kentucky (“Commission”), pursuant its January 20, 2026 Order in this case, for a short extension of time through January 30, 2026, to file responses to Post-Hearing data requests 15 and 16 issued by Commission Staff on January 20, 2026.

Commission Staff issued post-hearing data requests, consisting of 41 distinct requests (not including sub-parts) upon Kentucky Power on January 20, 2026. The January 20, 2026 procedural schedule in this case requires Kentucky Power to file its responses to data requests no later than January 27, 2026. Kentucky Power began working immediately to prepare responses to all 41 data requests, along with responses to another four data requests (not including sub-parts) from other intervening parties within that same time frame. Commission Staff post-hearing data requests 15 and 16 request revised and redlined copies of the Company’s tariff book. This document is nearly 200 pages in its full form, and therefore requires significant work to prepare. The Company is working diligently to prepare these documents, but due to the labor and time involved, cannot do so by the January 27, 2026 deadline. Kentucky Power requests a short extension of three additional business days, through January 30, 2026, to prepare and file the aforementioned responses. Kentucky Power will file those responses as soon as is practicable

before that time if possible. Kentucky Power is timely filing all other responses to all other post-hearing data requests and attachments thereto.

WHEREFORE, Kentucky Power Company respectfully requests that the Commission enter an Order:

1. Granting Kentucky Power a short extension of time through January 30, 2026, to file its responses to Commission Staff post-hearing data requests 15 and 16; and
2. Granting such further relief to which the Company may be entitled.
