## **Kentucky Power Company's Motion For Leave To Deviate**

Kentucky Power Company ("Kentucky Power" or "Company") moves the Public Service Commission of Kentucky ("Commission") pursuant to 807 KAR 5:001, Section 22 for leave to deviate from the requirements of the Commission's September 11, 2025 Order to file an electronic copy of any paper in accordance with the electronic filing procedures set forth in 807 KAR 5:001, Section 8, and to instead file three voluminous attachments to the Company's responses to the Commission Staff's second set and the Attorney General's and Kentucky Industrial Utility Customer, Inc.'s (collectively "AG-KIUC") first set of data requests with the Commission in electronic format on a USB drive. The deviation to file the information on a USB drive is necessary due to the large volume of information contained in the attachments. Kentucky Power consulted with and was instructed by Commission Staff regarding the requested filing procedure given the voluminous content of the identified attachments. In support of its motion, Kentucky Power states as follows:

There are three attachments to Kentucky Power's responses to Commission Staff's second set and AG-KIUC's first set of data requests that include files over 50MB in size: Attachment 1 to KPSC 2-19, Attachment 1 to AG-KIUC 1-68, and Attachment 1 to AG-KIUC 1-94.

When distributing such large files, it is typically the Company's practice to break the files into separate smaller files and file them through the Commission's electronic filing system. This approach, however, is impractical here, as the documents are not able to be broken into smaller files. Doing so would make navigating these documents difficult, if not impossible, and would disrupt formulas in the Excel spreadsheets that would materially alter the information therein. Moreover, the Company is unable to provide this information electronically via zip file because even after doing so, the zip files remained over 50MB. The Company therefore respectfully requests that the Commission grant a deviation, to the extent required, to file these attachments in electronic format on a USB drive to be hand delivered to the Commission's offices.

The USB will be mailed via overnight delivery to the Commission's offices and should be received on October 10, 2025. The Company also will upload the attachments to the Commission's internal document management system so that they can be accessed by Commission personnel in the interim until the USB is received.

WHEREFORE, Kentucky Power Company respectfully requests that the Commission enter an Order:

- 1. Granting the Company a deviation, to the extent required, to file Attachment 1 to KPSC 2-19, Attachment 1 to AG-KIUC 1-68, and Attachment 1 to AG-KIUC 1-94, in electronic format on a USB drive; and
  - 2. Granting such further relief to which the Company may be entitled.
