Kentucky Power Company’s Request To Submit Matter For Decision On The Record

In accordance with the Public Service Commission of Kentucky’s (“Commission”) September 5, 2025 Order, Kentucky Power Company (“Kentucky Power” or “Company”) respectfully requests that this matter be submitted for decision on the record and without a hearing. In support of its request, Kentucky Power states as follows:

The Commission opened this case and issued its procedural schedule by order dated September 5, 2025 (“Procedural Schedule”). The Procedural Schedule set the last day to intervene in this case as September 8, 2025. As of the date of this filing, no parties have requested nor been granted leave to intervene. Kentucky Power submitted its responses to Commission Staff’s first set of data requests on October 1, 2025, in conformity with the Procedural Schedule. No other data requests nor requests for information have been filed. The only milestones remaining on the Procedural Schedule are related to intervenor testimony and discovery to intervenors. The Procedural Schedule provides that Kentucky Power may request a hearing or to submit this matter for a decision on the record by November 3, 2025.

Given that there are no intervenors in this case, the remaining deadlines in the Procedural Schedule have no substantive effect. Kentucky Power therefore respectfully requests that this

matter be submitted for decision on the record as of the date of this filing and that the Company's request for deferral be granted.

However, the Company will defer to the Commission if the Commission or Commission Staff determine that a hearing is needed or would be beneficial to supplement the record of this matter with additional evidence so that the Company's application may be granted. In that event, the Company would be amenable to making its witnesses available for any such hearing at the convenience of the Commission. The Company also is willing to attend an informal conference with Commission Staff and the parties to discuss any outstanding issues, any evidence submitted, or to discuss any other matters that would aid in the handling and disposition of the case.
