APPLICATION

Comes now, Atmos Energy Corporation (“Atmos Energy” or “Company”) by counsel, pursuant to KRS 278.020(4), 807 KAR 5:001, Section 15(1), 807 KAR 5:001 Section 14 and other applicable law, and hereby tenders its application for a certificate of public convenience and necessity (“CPCN”) to apply for and obtain a franchise from the city of Lebanon, in Marion County, Kentucky (“Lebanon”), to provide natural gas transmission and distribution services, respectfully states as follows:

1. Atmos Energy is a Virginia and Texas corporation duly qualified under the laws of the Commonwealth of Kentucky to carry on its business in the Commonwealth. Atmos Energy is an operating public utility engaged in the business of supplying natural gas to the public in numerous cities, towns, and communities in Western and South-Central Kentucky.
2. Atmos Energy’s Articles of Incorporation, together with all amendments thereto, are on file with the Commission in Case No. 2021-00214. There have been no changes to the Articles of Incorporation since they were filed with the Commission in Case No. 2021-00214. Atmos Energy was incorporated in Texas on February 6, 1981 and Virginia on July 21, 1997. It is in good standing to operate in Kentucky and is in good standing to operate in all states of incorporation. Attached as Exhibit A is a Certification of Good Standing from the Kentucky Secretary of State.

3. Atmos Energy's principal operating office and place of business in Kentucky is 3275 Highland Pointe Drive, Owensboro, Kentucky 42303. The post office address of Atmos Energy is PO Box 650205, Dallas, Texas 26265-0205.

4. Lebanon is a municipal corporation situated in Marion County, Kentucky and is in an area presently served by Atmos Energy. Atmos Energy has been the owner of a franchise operation of the natural gas system within Lebanon immediately prior to the sale of a new franchise. Atmos Energy currently serves Lebanon by and through a natural gas distribution system owned by Atmos Energy.

5. The Lebanon City Council passed an Ordinance setting forth the terms and requirements for a new natural gas franchise. A copy of the Ordinance is attached as Exhibit B. Lebanon directed that bids for the sale of a natural gas franchise be received on or before 4:00 p.m. on September 5, 2025. A copy of the public notice advertising the request for bids which was published in *The Lebanon Enterprise* on Wednesday,

August 20, 2025 and the publisher's affidavit are attached as Exhibit C

6. As evidenced by the attached Ordinance, there is and will continue to be, a demand and need for continued natural gas service for Lebanon.

WHEREFORE, Atmos Energy respectfully requests the Commission to enter a certificate of public convenience and necessity authorizing it to bid on the aforesaid natural gas franchise for Lebanon and, if it is awarded such franchise, to operate the natural gas distribution system pursuant to such franchise. Upon obtaining a franchise from the City, the Company will file a true and correct copy of same with the Commission.

AN ORDINANCE OF THE CITY OF LEBANON, KENTUCKY, PROVIDING FOR THE CREATION AND SALE OF A FRANCHISE FOR THE PRIVILEGE OF CONSTRUCTING, TRANSPORTING, OPERATING, MAINTAINING AND DISTRIBUTING NATURAL GAS ALONG AND UNDER PUBLIC RIGHT OF WAY WITHIN THE CITY OF LEBANON, KENTUCKY, FOR A TERM OF TWENTY (20) YEARS IN CONSIDERATION FOR WHICH, THE SUCCESSFUL FRANCHISEE SHALL PAY TO THE CITY AN ANNUAL SUM EQUAL TO ONE PERCENT (1%) OF ITS REVENUES; AND FURTHER ESTABLISHING A BID PROCEDURE FOR THE AWARD OF SAID FRANCHISE TO THE SUCCESSFUL BIDDER.

WHEREAS, the existing natural gas franchise agreement between the City of Lebanon, Kentucky and Atmos Energy Corporation expires on December 31, 2025; and,

Sealed bids offered for the purchase of this franchise shall be publicly opened and read at 7:00 p.m. E.S.T. on September 8, 2025. All bids shall state the bidder's acceptance of the terms and provisions set forth in the attached franchise agreement.

The Mayor shall present all written bids to the City of Lebanon at its first meeting scheduled after the Bid Deadline for the City's consideration and approval. The City reserves the right to accept any bid, to reject any and all bids received, to waive any irregularities or informalities in awarding the franchise and to accept what, in its opinion, is the best responsive and responsible bid. In the event all bids are rejected, the City reserves the right to direct by resolution or ordinance that the franchise created hereunder be offered again for sale until a satisfactory bid is received and approved.





ORDINANCE NO. 2025-06

AN ORDINANCE DESIGNATING PARKING AREAS ON MONTGOMERY COURT WITHIN THE CITY OF LEBANON, KENTUCKY.

WHEREAS, the City of Lebanon has been presented with a request to remove parking in the Montgomery Court area of the City of Lebanon; WHEREAS, the City Council deems it desirable to promote the safety of its citizens and guests as well as the commercial interests of businesses located within the City and to eliminate parking spaces on Montgomery Court nearest its intersection with Spalding Avenue and Highway 429/St. Rose Road for traffic safety and visibility reasons;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEBANON, KENTUCKY:

SECTION I: Parking for purposes other than loading/unloading shall henceforth be prohibited 50 feet along Montgomery Court nearest its intersection with Spalding Avenue and Highway 429/St. Rose Road.

SECTION II: (A) That signage will be posted near the intersection of Montgomery Court, Spalding Avenue and Highway 429/St. Rose Road announcing no parking within 50 feet of that intersection. (B) That parking will still be allowed on Montgomery Court in areas further than 50 feet from the intersection of Montgomery Court, Spalding Avenue and Highway 429/St. Rose Road.

SECTION III: That the City Clerk and/or other City officials are hereby authorized and directed to take such action as shall be necessary in order to amend the City map, post no parking, loading/unloading and/or other required signs, and such other action as may be necessary and desirable as a result of these changes to said parking spaces in the above designated areas.

SECTION IV: All Ordinances or parts of Ordinances in conflict herewith are expressly repealed, but only to the extent of such conflict.

SECTION V: If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions hereof.

SECTION VI: This Ordinance shall become effective upon its second reading, passage and publication.


