





On December 19, 2025, Crab Run Solar Project, LLC ("Crab Run") filed an application with the Kentucky State Board on Electric Generation and Transmission Siting ("Siting Board") in Case No. 2025-00276. Crab Run is proposing to develop and construct an up to 45-megawatt alternating current merchant solar electric generating facility on approximately 400 acres of land in Marion County, Kentucky.

The proposed project will consist of approximately 110,052 photovoltaic solar panels and associated racking, approximately 12 inverters, a project substation transformer, and other necessary equipment to support the project.
