Comes now Crab Run Solar, LLC (“Crab Run”), by counsel, pursuant to KRS 278.700, et seq., 807 KAR 5:110, Section 2, and other applicable law, and does hereby tender its NOTICE OF INTENT to file an application, on or before December 31, 2025, for a Certificate to Construct an up to 45-megawatt (“MW”) solar electric generating facility in Marion County, Kentucky (the “Project”), respectfully stating as follows:

1. Pursuant to 807 KAR 5:110, Section 2(2)(a), the forthcoming application will be filed by:

2. Pursuant to 807 KAR 5:110, Section 2(2)(b), the Project will be capable of generating up to 45 MWs of electricity on approximately 400 acres with approximately 110,052 photovoltaic solar panels and associated racking, approximately 12 inverters, and a project substation transformer.

3. Pursuant to 807 KAR 5:110, Section 2(2)(c), the electric generation facility for the Project is located in Marion County, Kentucky. The Project does not yet have a street address but is located approximately 9 miles northwest of Lebanon, Kentucky in the northwestern portion of Marion County (GPS coordinates 37.608236, -85.367630).
4. The Project site is not located within the limits of any city.
5. Marion County, Kentucky, does not have a planning and zoning commission. There are no local zoning or setback requirements applicable to the Project.
6. Pursuant to 807 KRS 278.704(4), the applicant expects to request a deviation from the setback requirements found in KRS 278.704(2).
