**Kentucky Power Company’s Notice of Intent to Place Proposed Rates
Into Effect Subject to Refund Pursuant to KRS 278.190(2)**

The Public Service Commission of Kentucky’s (“Commission”) September 26, 2025 Order suspended the effective date for the rates and terms and conditions proposed by Kentucky Power Company (“Kentucky Power”) in this proceeding¹ for one day, until September 30, 2025, pursuant to KRS 278.190(2). In the event that the Commission does not issue a final order in this proceeding before that date, KRS 278.190(2) also allows Kentucky Power to place the proposed rates and terms and conditions into effect, subject to refund, after notifying the Commission in writing of its intention so to do.

Kentucky Power hereby notifies the Commission, pursuant to KRS 278.190(2), that Kentucky Power intends to place the rates and terms and conditions proposed in Kentucky Power’s tariffs into effect for service rendered on and after September 30, 2025.² The Company is placing these rates and terms and conditions into effect, subject to refund, pending the Commission’s final
