Response: Rowan must flush significant levels of its system to meet required DOW water quality standards.

In addition, Rowan Water has been experiencing greater than 20% line loss in the past few years. Rowan Water is diligently working to reduce its line loss.

b. Explain why Rowan Water recorded flushing 204,406,000 gallons, which is an increase from 166,144,000 in 2023.

Response: The increase in system flushing has been necessary to maintain water quality, due to several unusual occurrences this year. Rowan Water has had several projects going on in the past year. We have replaced several creek crossings in our service area. We have built two new pump stations and laid lines around them. This caused more flushing to take place. The weather this year has also contributed to increased system flushing. The extreme cold weather in January of this year caused more breaks than usual. High water in the spring caused three creek crossing to wash out one night. The very dry summer has caused more leaks than usual.
