Due solely to the recent approval by the Kentucky Public Service Commission ("KPSC") of an increase in purchase rates for water supplied by the City of Nicholasville, the Jessamine-South Elkhorn Water District ("JSEWD") has filed an application with the KPSC for approval of an adjustment in rates effective September 1, 2025.
