MOTION FOR INFORMAL CONFERENCE

Comes now East Kentucky Power Cooperative, Inc. (“EKPC”), by and through the undersigned counsel, pursuant to 807 KAR 5:001 Section 9 and other applicable law and does hereby submit its request to conduct an informal conference in this case. EKPC requests to hold this conference virtually on or before **February 6, 2026**. In support of this motion, EKPC respectfully states as follows:

1. On November 10, 2025, EKPC filed an application requesting the Commission grant a Certificate of Public Convenience and Necessity (“CPCN”) for a 161 kV transmission line in Pulaski County, Kentucky.
2. The Commission issued an Order on November 20, 2025, that allowed for two requests for information and a date to submit the case on the record or request a public hearing. EKPC provided responses to Commission Staff’s First and Second Request for Information.¹

EKPC requested to submit the case on the record.² Commission Staff issued a third request for information on January 30, 2026.³

3. EKPC believes an informal conference will provide assistance and clarity regarding the transmission line that has been proposed.

For the foregoing reasons, EKPC respectfully requests that the Commission schedule an informal conference to discuss the issues present in the application.
