APPLICATION

Comes now, Atmos Energy Corporation ("Atmos Energy" or "Company") by counsel, pursuant to KRS 278.020(4), 807 KAR 5:001, Section 15(1), 807 KAR 5:001 Section 14 and other applicable law, and hereby tenders its application for a certificate of public convenience and necessity ("CPCN") to apply for and obtain a franchise from the city of Powderly, in Muhlenberg County, Kentucky ("Powderly"), to provide natural gas transmission and distribution services, respectfully states as follows:

- 1. Atmos Energy is a Virginia and Texas corporation duly qualified under the laws of the Commonwealth of Kentucky to carry on its business in the Commonwealth. Atmos Energy is an operating public utility engaged in the business of supplying natural gas to the public in numerous cities, towns, and communities in Western and South-Central Kentucky.
- 2. Atmos Energy's Articles of Incorporation, together with all amendments thereto, are on file with the Commission in Case No. 2021-00214. There have been no changes to the Articles of Incorporation since they were filed with the Commission in Case No. 2021-00214. Atmos Energy was incorporated in Texas on February 6, 1981 and Virginia on July 21, 1997. It is in good standing to operate in Kentucky and is in good standing to operate in all states of incorporation. Attached as **Exhibit A** is a Certification of Good Standing from the Kentucky Secretary of State.

3. Atmos Energy's principal operating office and place of business in Kentucky is 3275 Highland Pointe Drive, Owensboro, Kentucky 42303. The post office address of Atmos Energy is PO Box 650205, Dallas, Texas 26265-0205.

- 4. Powderly is a municipal corporation situated in Muhlenberg County, Kentucky and is in an area presently served by Atmos Energy. Atmos Energy has been the owner of a franchise operation of the natural gas system within Powderly immediately prior to the sale of a new franchise. Atmos Energy currently serves Powderly by and through a natural gas distribution system owned by Atmos Energy.
- 5. The Powderly City Council passed an Ordinance setting forth the terms and requirements for a new natural gas franchise. A copy of the Ordinance is attached as **Exhibit B**. Powderly directed that bids for the sale of a natural gas franchise be received on or before 4:00 p.m. on October 27, 2025. A copy of the public notice advertising the request for bids which was published in *Leader-News* on Tuesday, September 23, 2025

and the publisher's affidavit are attached as Exhibit C

6. As evidenced by the attached Ordinance, there is and will continue to be, a demand and need for continued natural gas service for Powderly.

WHEREFORE, Atmos Energy respectfully requests the Commission to enter a certificate of public convenience and necessity authorizing it to bid on the aforesaid natural gas franchise for Powderly and, if it is awarded such franchise, to operate the natural gas distribution system pursuant to such franchise. Upon obtaining a franchise from the City, the Atmos Energy will file a true and correct copy of same with the Commission.

EXHIBIT B ORDINANCE

ORDINANCE <u>25-03</u>

AN ORDINANCE OF THE CITY OF POWDERLY, KENTUCKY, PROVIDING FOR THE CREATION AND SALE OF A FRANCHISE FOR THE PRIVILEGE OF CONSTRUCTING, TRANSPORTING, OPERATING, MAINTAINING AND DISTRIBUTING NATURAL GAS ALONG AND UNDER PUBLIC RIGHT OF WAY WITHIN THE CITY OF POWDERLY, KENTUCKY, FOR A TERM OF TWENTY YEARS IN CONSIDERATION FOR WHICH, THE SUCCESSFUL FRANCHISEE SHALL PAY TO THE CITY AN ANNUAL SUM EQUAL TO .40 CENTS PER METER DURING THE FIRST FIVE YEARS; .45 CENTS PER METER DURING THE SECOND FIVE YEARS; .50 CENTS PER METER DURING THE THIRD FIVE YEARS; AND .55 CENTS PER METER DURING THE FOURTH FIVE YEARS; AND FURTHER ESTABLISHING A BID PROCEDURE FOR THE AWARD OF SAID FRANCHISE TO THE SUCCESSFUL BIDDER.

WHEREAS, the existing natural gas franchise agreement between the City of Powderly, Kentucky and Atmos Energy Corporation expires on December 12, 2025; and,

WHEREAS, the City has determined that it is in the best interest of its citizens to create and offer for sale a new natural gas franchise.

BE IT ORDAINED BY THE [MUNICIPALITY], KENTUCKY (hereinafter referred to as the "City") that the Mayor of the City, or such other person as the Mayor may designate, shall offer for sale, to the highest and best bidder, a non-exclusive franchise to enter upon, acquire, construct, operate, maintain and repair in the public right of way of the City, a gas distribution system within the corporate boundaries of the City, subject to the provisions of the Franchise Agreement attached hereto and incorporated herein by reference.

Sealed bids offered for the purchase of this franchise shall be publicly opened and read at 4_P.m. D.S.T. on October 27 2025. All bids shall state the bidder's acceptance

of the terms and provisions set forth in the attached franchise agreement.

The Mayor shall present all written bids to the City of Powderly at its first meeting scheduled after the Bid Deadline for the City's consideration and approval. The City reserves the right to accept any bid, to reject any and all bids received, to waive any irregularities or informalities in awarding the franchise and to accept what, in its opinion, is the best responsive and responsible bid. In the event all bids are rejected, the City reserves the right to direct by resolution or ordinance that the franchise created hereunder be offered again for sale until a satisfactory bid is received and approved.

The franchise created by this ordinance shall become effective when the franchise agreement is signed by the successful bidder and the City.
