**MOTION TO SUBMIT CASE FOR ADJUDICATION  
ON THE ADMINISTRATIVE RECORD**

Comes now Licking Valley Rural Electric Cooperative Corporation (“Licking Valley”), by counsel, and hereby moves the Kentucky Public Service Commission (“Commission”) to submit the case for a decision based upon the existing record and without the need for a hearing, respectfully stating as follows:

On December 19, 2025, the Commission issued an Order opening an investigation for the two-year review of Licking Valley’s application of the Fuel Adjustment Clause from November 1, 2022 through October 31, 2024. The December 19, 2025 Order contained a procedural schedule that allowed for the filing of an affidavit of compliance and a deadline for motions to intervene in the case. There have been no motions for intervention filed in this case. Licking Valley has until March 20, 2026, to request a hearing or state that the case should be submitted on the record.

Since there are no intervenors in this case, Licking Valley believes the administrative record is complete and it would be appropriate for the Commission to make a ruling based upon the record. Licking Valley respectfully requests a decision from the Commission based upon the existing record.

WHEREFORE, Licking Valley moves the Commission to submit the case on the existing administrative record.
