

STAFF'S THIRD REQUEST FOR INFORMATION

1. Refer to Laurel District No. 2's response to Commission Staff's First Request for Information (Staff's First Request), Item 11b, 11\_b\_Appointment\_of\_Commissioners\_by\_Fiscal\_Court\_2024\_and\_2025.pdf, page 5 October 30, 2025. The Fiscal Court minutes identify the appointments of Teresa Brewer and Steven Cornn. Confirm the Fiscal Court minutes provided are for a re-appointment, and not the initial appointment, for Steven Cornn. If it is a re-appointment, provide the appointment date and documentation from the Fiscal Court that authorized his initial appointment.

**Response: Confirmed. Refer to LCWD#2's response to Commission Staff's initial request for information, item 11.b. The response included Fiscal Court letters dated October 11, 2021 and October 30, 2025 appointing Teresa Brewer and Steve Cornn to the LCWD#2 board. Laurel District No 2 provided the initial registration for Steven Cornn's 12 hours of new commissioner training at Pine Mountain State Resort Park on July 20 - 21, 2022 but did not provide the certificate of completion for the training. Provide the certificate of completion for Steven Cornn's new commissioner training.

**Response: Steven Cornn attended the training at PMSRP however, he did not receive a certificate. I requested a certificate from Jamie Wilson and was informed the PSC did not have a record of Steven Cornn attending the training and they did**

not have a record of payment for him attending the session. We provide the registration, cancelled check verifying payment, copy of training materials received, notes taken, and sworn statement of Mr. Cornn demonstrating his attendance at the July 2022 Water Commissioner Training. Mr. Cornn sat next to Kentucky State Police Detective, James Creekmore who was also a Cumberland Fall Highway Water District Commissioner at the time. Mr. Creekmore provided the attached sworn statement.
