

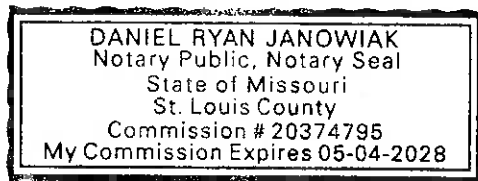

On December 11, 2025, Bluegrass Water Utility Operating Company, LLC (the "Company") filed for a general rate increase with the Kentucky Public Service Commission ("PSC"). At that time, the Company mailed notice of the proposed rates to its customers. Consistent with the PSC's direction, the Company is providing this updated notice, which is largely identical to the notice sent on 12/11/2025, except for this paragraph and the highlighted paragraph below, which is new.

Please take notice of the following information about the proposed rate adjustment that is presented below:

The rates contained in this notice are the rates proposed by the Company, but the PSC, the state agency that regulates all utility services in Kentucky, may order rates to be charged that differ from the proposed rates found in this notice. The Company has proposed raising residential rates from the present rate of \$77.77 to the proposed rate of \$114.00 which represents an increase of \$36.23 or 46.6%. The Company has also proposed raising the multi-residential rate from \$58.33 to \$85.50 and the commercial rate from \$197.43 to \$285.00. Respectively, these changes represent an increase of \$27.17 or 46.6% and \$87.57 or 44.4%. The date the proposed rates were filed with the PSC was 12/11/2025; the proposed effective date of the rates is for service rendered on and after 1/31/2026. As there are only flat rates included in the existing tariff or which affect existing customers, the average customer usage is unknown and the effect the proposed rate will have on (i) the residential class is an increase of \$36.23 or 46.6%; (ii) the multi-residential class is an increase of \$27.17 or 46.6%; and (iii) the commercial class is an increase of \$87.57 or 44.4%.

In addition to changes in tariff rates, the submission proposes other changes to the Company's residential wastewater tariff, including but not limited to changes to the terms and conditions relating to new service connections, including adding a new inspection fee of \$82.50, which is only charged in the event a new customer opts to have a licensed plumber make the service connection. The inspection fee is new and therefore consists of an increase of \$82.50 or 100%, and will not affect existing customers' average usage or average bill as it only applies to new customers opting to have a licensed plumber make the required service connection. The remaining changes to the tariff include: (1) changes to the service disconnection terms and conditions; (2) unification of wastewater rates for all Kentucky operations; and (3) any other adjustments deemed appropriate by the PSC. At that time, the Company mailed notice of the proposed rates to its customers. Consistent with the PSC's direction, the Company is providing this updated notice, which is largely identical to the notice sent on 12/11/2025, except for this paragraph and the highlighted paragraph below, which is new.

Please take notice of the following information about the proposed rate adjustment that is presented below:

The rates contained in this notice are the rates proposed by the Company, but the PSC, the state agency that regulates all utility services in Kentucky, may order rates to be charged that differ from the proposed rates found in this notice. The Company has proposed raising residential rates from the present rate of \$77.77 to the proposed rate of \$114.00, which represents an increase of \$36.23 or 46.6% and also represents the effect upon the average bill for residential customers. The Company has also proposed raising the non-residential minimum charge from \$197.43 to \$285.00 which represents an increase of \$87.57 or 44.4%. The non-residential usage charge has been proposed to increase from \$11.67 per 1,000 gallons to \$55.86 per 1,000 gallons representing an increase of \$44.19 or 378.7%. The date the proposed rates were filed with the PSC was 12/11/2025; the proposed effective date of the rates is for service rendered on and after 1/31/2026. For the non-residential Delaplain customers, the average customer usage is 86,879 gallons and the effect the proposed rate will have on the average bill for each customer is an increase of \$3,926.86 or 324.2%.

In addition to changes in the tariff rates, the submission proposes other changes to the Company's residential wastewater tariff, including but not limited to changes to the terms and conditions relating to new service connections, including adding a new inspection fee of \$82.50, which is only charged in the event a new customer opts to have a licensed plumber make the service connection. Please take notice of the following information about the proposed rate adjustment that is presented below:

The rates contained in this notice are the rates proposed by the Company, but the PSC, the state agency that regulates all utility services in Kentucky, may order rates to be charged that differ from the proposed rates found in this notice. The Company has proposed raising residential rates from the present rate of \$77.63 to the proposed rate of \$106.12, which represents an increase of \$28.49 or 36.7%. The date the proposed rates were filed with the PSC was 12/11/2025; the proposed effective date of the rates is for service rendered on and after 1/31/2026. As there are only flat rates included in the existing tariff or which affect existing customers, the average customer usage is unknown and the effect the proposed rate will have on the average bill for each customer is an increase of \$28.49 or 36.7%.

In addition to changes in the tariff rates, the submission proposes other changes to the Company's water tariff, including but not limited to changes to certain non-recurring charges. The Company proposes changes to the terms and conditions relating to new service connections, including modifying the connection charge and adding a new inspection charge of \$82.50, which is only charged in the event a new customer opts to have a licensed plumber make the service connection. The inspection fee is new and therefore consists of an increase of \$82.50 or 100%, and will not affect existing customers' average usage or average bill as it only applies to new customers opting to have a licensed plumber make the required service connection. Similarly, the connection charge is only incurred in new service connections, and therefore these charges will have no effect upon the average usage or the average bill for each existing customer. The Company further proposes a 10% late payment penalty and a \$15.00 returned check charge. Because the late payment penalty and returned check charge are only incurred in the event of a late payment or a returned check, these charges will have no effect upon the average usage or the average bill of a customer. The summary of these non-recurring charges is as follows:
