**MOTION OF BLUEGRASS WATER UTILITY OPERATING COMPANY, LLC  
FOR A VIRTUAL INFORMAL CONFERENCE**

Bluegrass Water Utility Operating Company, LLC (“Bluegrass Water” or the “Company”), by counsel, hereby moves the Kentucky Public Service Commission (the “Commission”) to schedule a virtual informal conference in the above-styled proceeding for the purpose of discussing a modified procedural schedule. Bluegrass Water requests that the informal conference be scheduled at Commission Staff’s and the parties’ earliest convenience, preferably during the week of March 16, 2026 – March 20, 2026.

Commission regulations authorize any party to a Public Service Commission case to request that the Commission convene a conference “for . . . any other matter that may aid in the handling and disposition of the case.”<sup>1</sup> In the course of responding to the most recent round of requests for information, Bluegrass Water discovered certain errors in the financial workbook presented as Exhibit 9 to the Application. The Company is presently working to identify the source of the errors and correct any information that may have been impacted. To allow for sufficient time to rectify the identified errors, the Company requests a virtual informal conference to discuss a modification to the procedural schedule of this case. Given that supplemental data requests are

due to be served on Friday, March 20, 2026, an informal conference would serve the interests of all parties and facilitate an adequate resolution.

WHEREFORE, Bluegrass Water respectfully requests that the Commission schedule a virtual informal conference in this matter as soon as practicable to discuss a modified procedural schedule, identify any unresolved issues, and otherwise facilitate the efficient resolution of this case.
