NOTICE OF INTENT

The Project will connect to a substation to be constructed onsite and contained entirely within the Project's footprint.
- 3. Pursuant to 807 KAR 5:110, Section 2(2)(c), the Project is located in unincorporated Muhlenberg County, Kentucky, near the city of Central City. The Project has a street address of 1850 W. Everly Brothers Boulevard, Central City, Kentucky, 42330. Its latitude-

longitude coordinates are 37.254463° N, 87.120831° W. No portion of the Project is located within the boundaries of any municipality.
