**RESPONSE BY THE CITY OF ALBANY TO COMMISSION'S STAFF**  
**FIRST REQUEST FOR INFORMATION**

Comes the City of Albany, by and through counsel, and, in response to the first request for information, states and declares as follows:

1. **Question:** Refer to the invoices sent to Cumberland County Water District for the period of December 15, 2017, through April 8, 2024. Each invoice appears to have a \$5 fee listed on it. Explain what that fee is for and provide documentation of when it was approved for any tariff.

**Answer:** The \$5.00 fee is a late payment charge. This was approved by city ordinance in the past. Please see affidavit of Sydney Hunter Albany Municipal Water Works Billing Manager.

2. **Question:** Refer to the invoices sent to Cumberland County Water District for the period of April 25, 2024, through December 22, 2025. Starting in April, 2024, in place of the \$5 fee discussed above, there is a variable fee listed on the invoices. Explain what that fee is, how it was calculated, and provide documentation for when it was approved for any tariff.

**Answer:** The variable fee is a late payment charge of 10%. It was pursuant to city ordinance. Please see affidavit of Sydney Hunter, Albany Municipal Water Works Billing Manager. Also see transactional history as referred to in said affidavit.


3. **Question:** Provide any invoices sent to Cumberland County Water District since the January 12, 2026 filing in this proceeding.

**Answer:** Please see invoice dated January 14, 2026.

4. **Question:** Refer to the response of Albany at unnumbered page 2. Provide a copy of the 2009 contract between Albany and Cumberland County Water District.

**Answer:** The contract is dated November 5, 2003 but was stamped as received by the PSC on August 13, 2009. See attached filing.
