

AMENDED RESOLUTION OF THE
HARRISON COUNTY WATER ASSOCIATION, INC. ("HCWA")
RESOLUTION NO. 2025-00008 (AMENDED)

JANUARY 12, 2026 (DATE)

WHEREAS, THE HARRISON COUNTY WATER ASSOCIATION, INC. ("HCWA"), PREVIOUSLY APPROVED A RESOLUTION DATED DECEMBER 17, 2025, BUT DUE TO ERRORS IN THE PRIOR CALCULATIONS AND IN REVIEW OF THE CALCULATION IT BECAME EVIDENT THAT THE PRIOR CALCULATED PURCHASED WATER ADJUSMTENT FACTOR WAS IN ERROR, AND TO CORRECT THE PURCHASED WATER ADJUSTMENT FACTOR AND IMPLEMENTATION OF THE SAME INTO PROPOSED PURCHASED WATER ADJUSTMENT PASS THROUGH RATE INCREASE TO ITS CUSTOMERS, THE ATTACHED RATES SHOWING CURRENT RATES, NEW RATES, AND DOLLAR AMOUNT CHANGE AND PERCENTAGE CHANGE FOR ALL FIVE (5) CLASSES OF METERS UTILIZED BY HARRISON COUNTY WATER ASSOCIATION, INC.;

AND WHEREAS, HCWA having been made aware that Kentucky American Water Company was approved by KY PSC to increase its wholesale water rates from \$0.0049527, plus a QIP, plus KY River w/fee (if applicable), to a water rate of \$0.0083091 per gallon and kY River w/fee (if applicable), and HCWA desires to proceed with its wholesale water purchase application by supplementing its application with the correct and satisfactory information to KY PSC;

AND WHEREAS, HCWA having called a special meeting and all board of directors who were in attendance have singed in agreement to proceed with this amended resolution to amend its proposed water purchase adjustment rates as attached, and the resolution is approved by majority consent, as evidenced by their signatures below.

THEREFORE IT IS HEREBY RESOLVED THAT IT IS APPROVED TO AMEND THE APPROVED RATES FOR THE PURCHASED WATER ADJUSTMENT, FROM TH EPRIOR RESOLUTION DATED DECEMBER 17, 2025, TO THE RATES AS ATTACHED HERETO AND IDENTIFIED AS EXHIBIT "A", CONSISTING OF TWO (2) PAGES, AS PART OF HCWA'S PURCHASED WATER ADJUSTMENT REQUEST..


