RE: BARDSTOWN WATER RATE INCREASE

Mr. Cissell,

The City of Bardstown recently completed a Cost of Service Study (COS) for all customer classes including each wholesale customer. The cost of service study was performed by Connie Allen of Salt River Engineering utilizing AWWA's method and following PSC guidelines. The COS rate for North Nelson Water District is \$3.63 per 1000 gallons and a customer charge of \$49.77. Bardstown desires to continue selling North Nelson water for years to come and will continue to make investments in its system to do so. Bardstown along with its consultant Connie Allen, PE, Salt River Engineering, met with you, member of your board and legal counsel in good faith to share the results of the study and offer the negotiated rate of \$3.50 per thousand gallons and waive the customer charge.

We ask North Nelson to provide a letter indicating its consent to the negotiated rate. Bardstown will submit the official Notice and Tariff sheet and all applicable information and the effective date of the rate be on or about February 2, 2026. A copy of the Notice and Tariff sheet is attached herein.

WHOLESALE CUSTOMER NOTICE

The City of Bardstown is providing notice that it plans to file a tariff with the Public Service Commission, on or before December 23, 2025, to increase its wholesale water rate to the North Nelson Water District.

The Current Rate is \$2.72 per thousand gallons and was last raised in 2023. A new rate is proposed to be implemented and become effective for water service rendered on or about Monday, February 2, 2026 with a new rate per 1,000 gallons:

North Nelson Water District purchased an average of 3,208,846 gallons of water during the previous 12 months with an average bill of \$8,728.06. Under the proposed rate, North Nelson Water District's average monthly bill will be \$11,230.96. This is an increase of \$2,502.90 per month.

Water flowing through the meter(s) before the effective date will be charged at the previous rate while water flowing through the meter(s) on and after the new effective date will be charged at the new rate(s).

This filing may be examined at the utility's office inside Bardstown City Hall located at 220 North Fifth Street, Bardstown, Kentucky; Monday – Friday from 8:00 am - 4:30 pm.

Intervention may be requested by submitting a timely written request for intervention by mail to the Public Service Commission, Post Office Box 615, Frankfort, Kentucky 40602. The request for intervention must establish the grounds for the request including the status and interest of the party.

If the Public Service Commission does not receive a written request for intervention within thirty (30) days of the providing of this notice, the Public Service Commission may take final action on the filing.

Customer rates will increase by \$0.10 per 1,000 gallons used. The proposed change will be effective for service rendered on and after February 2, 2026.

RESOLUTION NO. 2026-01-01

**A RESOLUTION OF THE BOARD OF COMMISSIONERS
OF THE NORTH NELSON WATER DISTRICT ADJUSTING
WATER RATES AND CHARGES TO OFFSET THE CITY
OF BARDSTOWN WHOLESALE RATE INCREASE**

WHEREAS, the City of Bardstown (“Bardstown”) is one of North Nelson Water District’s (“District”) wholesale water providers;

WHEREAS, on December 19, 2025, Bardstown filed an application with the Kentucky Public Service Commission (“PSC”) seeking to increase the wholesale water rate that Bardstown charges the District from \$2.72 to \$3.50 per 1,000 gallons (See PSC Case TFS2025-00556), effective February 2, 2026;

WHEREAS, based upon the water purchases from Bardstown during the previous 12 months, the estimated annual increased cost to the District will be **\$31,030.97**;

WHEREAS, prudent financial management dictates that the District take immediate action to adjust its retail rates commensurate with Bardstown’s wholesale rate increase; and

WHEREAS, KRS 278.015 and 807 KAR 5:068 provide the legal mechanism

for the District to increase its water rates commensurate with Bardstown's wholesale rate increase via a Purchased Water Adjustment ("PWA").

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE BOARD OF COMMISSIONERS OF NORTH NELSON WATER DISTRICT AS FOLLOWS:

Section 1. The facts, recitals, and statements contained in the foregoing preamble of this Resolution are true and correct and are hereby affirmed and incorporated as a part of this Resolution.

Section 2. The PWA factor is **\$0.10** per 1,000 gallons;

Section 3. All tiers of water usage set forth in the District's existing tariff shall be increased by **\$0.10** per 1,000 gallons, subject to any minor adjustment that may be made by the PSC.

Section 4. The monthly water rates to be charged to and collected from the customers and users of the water system of the District shall be as set forth in **Appendix A**, which is attached hereto and is incorporated herein by reference as a part of this Resolution. The rates and charges set forth in **Appendix A** are subject to any minor adjustment that may be made by the PSC. These monthly rates and charges shall be in effect for all water service rendered on and after February 2, 2026.

Section 5. The General Manager is hereby authorized and directed to

execute and file the PWA Application, Tariff Sheet, and all other documents that may be required by the PSC.



Section 7. This Resolution shall take effect upon its adoption.
