The Campbellsville Water & Sewer Committee met on March 25, 2025 and recommended to the Campbellsville City Council an increase in Larue County Water District's rate for water service from Campbellsville Water.

The Wholesale Water Rate for Larue County Water District will increase from \$3.48 per 1000 gallons to \$3.59 per 1,000 gallons.

The Campbellsville City Council had the first reading of the proposed rate increase on Monday, June 16, 2025, and the anticipated second reading on Monday, July 21, 2025.

The proposed rate increase will be effective for water used on and after August 1, 2025.

ORDINANCE NO. 25-05

AN ORDINANCE AMENDING ORDINANCE 24-07 ESTABLISHING WATER RATES FOR CERTAIN WHOLESALE CUSTOMERS OF THE CITY OF CAMPBELLSVILLE, KENTUCKY THROUGH THE CAMPBELLSVILLE WATER & SEWER SYSTEM

* * * * *

Whereas, the City of Campbellsville through the Campbellsville Water & Sewer System provide water to persons residing within the corporate boundaries of the City of Campbellsville and to persons residing in Taylor County, Kentucky, but outside the corporate boundaries of the City of Campbellsville; and

Whereas, the City of Campbellsville desires and intends to provide water and sewer services to the residents of the City of Campbellsville and Taylor County, Kentucky in such a way as to cover its costs, but not to seek a profit; and

Whereas, the cost of operating the Campbellsville Water & Sewer System has increased over time and the infrastructure owned by the Campbellsville Water & Sewer System is in need of repairs and improvements and will need repairs and improvements in the future; and

Whereas, revenues generated from the operations of the Campbellsville Water & Sewer System at the existing rates are inadequate to cover the costs associated with continued operations, repairs and improvements to the system; and

Whereas, the Campbellsville Water & Sewer System has a written contract for providing water to the Lebanon Water Works which involved the construction of certain infrastructure to accommodate the Lebanon Water Works's need for water now and in the future. The rate charged to the Lebanon Water Works is governed by the terms and conditions of the written contract and this Ordinance does not govern the rates charged or to be charged to Lebanon Water Works

Whereas, the City Council of the City of Campbellsville intends to raise rates for certain wholesale water customers so as to cover the increased costs of operation which the Campbellsville Water & Sewer System have incurred and are incurring.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMPBELLSVILLE, KENTUCKY as follows:

WHOLESALE CUSTOMER NOTICE

The City of Bardstown is providing notice that it plans to file a tariff with the Public Service Commission, on or before November 26, 2025, to increase its wholesale water rate to the Larue County Water District No. 1.

The Current Rate is \$2.72 per thousand gallons and was last raised in 2023. A new rate is proposed to be implemented and become effective for water service rendered on and after January 1, 2026 with a new rate per 1,000 gallons:

RESOLUTION NO. 2026-01-12

**A RESOLUTION OF LARUE COUNTY WATER DISTRICT NO.1
ADJUSTING ITS WATER RATES TO OFFSET THE CITY OF
CAMPBELLSVILLE AND CITY OF BARDSTOWN WHOLESALE
RATE INCREASE**

WHEREAS, the City of Campbellsville, City of Bardstown, Green-Taylor Water District, and Hardin County Water District #2 supplies potable water to Larue County Water District No.1 on a wholesale basis'

WHEREAS, on December 31, 2025 the City of Bardstown received approval from the Public Service Commission in Filing No. TFS2025-00529 to increase its wholesale rate to Larue County Water District No.1 effective January 1, 2026;

WHEREAS, on July 31, 2025 the City of Campbellsville received approval from the Public Service Commission in Filing No. TFS2025-00278 to increase its wholesale rate to Larue County Water District No.1 effective August 1, 2025;

WHEREAS, on July 1, 2025 the Hardin County Water District #2 received approval from the Public Service Commission in Case No. 2025-00167 to increase its wholesale rate to Larue County Water District No.1 effective July 1, 2025;

WHEREAS, on August 6, 2025 the Green-Taylor Water District received approval from the Public Service Commission in Case No. 2025-00235 to increase its wholesale rate to Larue County Water District No.1 effective August 6, 2025;

WHEREAS, based upon the water purchases from the City of Campbellsville, City of Bardstown, Green-Taylor Water District, and Hardin County Water #2 during the previous 12 months, the estimated annual increased cost to Larue Count Water District No. 1 will be **\$ 90,777.86**;

WHEREAS, prudent financial management dictates that Larue County Water District take action to adjust its retail rates commensurate with the City of Campbellsville, City of Bardstown, Green-Taylor Water District, and Hardin County Water #2 wholesale rate increase; and

WHEREAS, KRS 278.015 and 807 KAR 5:068 provide the legal mechanism for Larue County Water District No. 1 to increase its water rates to commensurate with the City of Campbellsville, City of Bardstown, Green-Taylor Water District, and Hardin County Water #2 wholesale rate increase via a Purchased Water Adjustment (“PWA”)

NOW, THEREFORE, THE BOARD OF COMMISSIONERS OF LARUE COUNTY WATER DISTRICT NO.1 DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. The facts, recitals, and statements contained in the foregoing preamble of this Resolution are true and correct and are hereby affirmed and incorporated as a part of this Resolution.

Section 2. The PWA factor is **\$.42** per 1,000 gallons.

Section 3. All tiers of water usage and the wholesale water rate set forth in Larue County Water District No. 1's existing tariff shall be increased by **\$.42** per 1,000 gallons, subject to any minor adjustment that may be made by the PSC.

Section 4. The monthly water rates to be charged to and collected from the customers and users of the water system of Larue County Water District No.1 shall be as set forth in **Exhibit C**, which is attached hereto and is incorporated herein by reference as a part of this Resolution. The rates set forth in **Exhibit C** are subject to any minor adjustment that may be made by the PSC. These monthly rates shall be in effect for all water service rendered on and after January 1, 2026 upon PSC approval.






