Those present were: John Pedigo, Frances Howard, Brenda Turner, Will Downing, Jeremy Jones, Amanda Frye and Chris Veach.

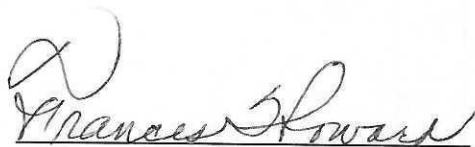

We spoke about The Tank and Fire Hydrant Bidding would be ran in the paper on Jan. 31st. and looked over the CDs.

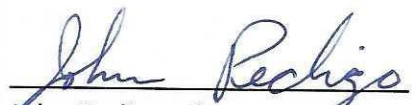
There being no other business the meeting was adjourned at 6:32 p.m. by a motion from Jeremy Jones and seconded by Frances Howard. Motion carried.

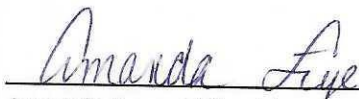

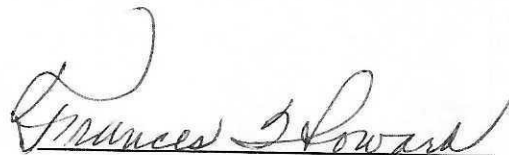
Motion by Frances Howard and seconded by Jeremy Jones to approve the Financial Reports as presented. Invoices were available for Commissioners viewing

Motion by Will Downing and seconded by Frances Howard to approve the Financial Reports as presented. Invoices were available for Commissioners viewing.

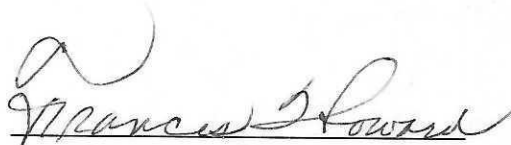
We had spoken about the Hydrant Rehab & Tank Rehab being complete just waiting on the rest of the funding to be finalized.

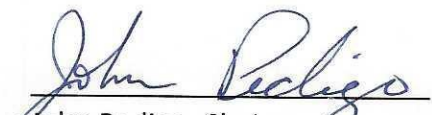
There being no other business the meeting was adjourned at 6:55 p.m. by a motion from Will Downing and seconded by Frances Howard. Motion carried.

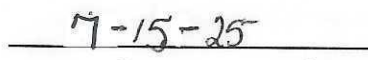

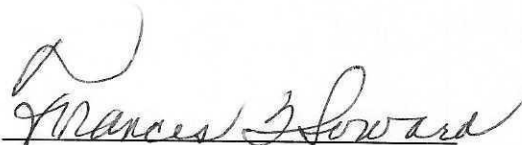

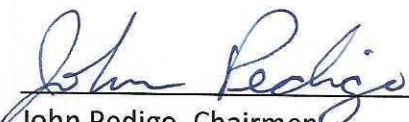

Fountain Run Water Commissioners met in the Water Office on Aug. 19, 2025, at 6:00 p.m. for a regular meeting.

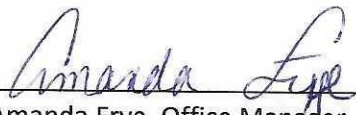
Those presents were: John Pedigo, Frances Howard, Brenda Turner, Will Downing, Jeremy Jones, Amanda Frye, and Chris Veach.

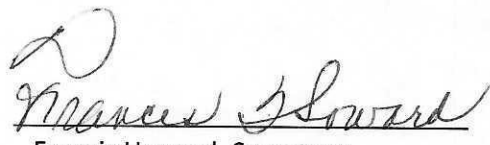

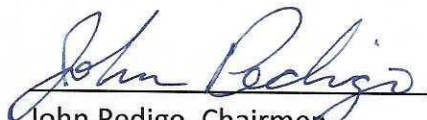

Those presents were: Frances Howard, Will Downing, Jeremy Jones, Kenneth Jackson, Amanda Frye and a visitor John Jackson.

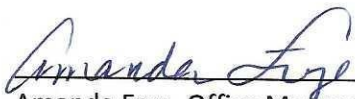

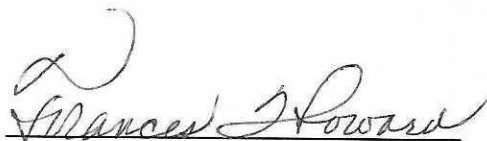
Motion by Frances Howard and seconded by Will Downing to approve the Financial Reports as presented. Invoices were available for Commissioners' viewing.

Motion by Brenda Turner and seconded by Will Downing to approve the Financial Reports as presented. Invoices were available for Commissioners' viewing.

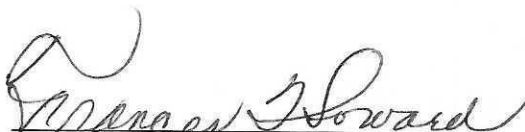

Fountain Run Water Commissioners met in the Water Office on November 18, 2025, at 6:00 p.m. for a regular meeting.

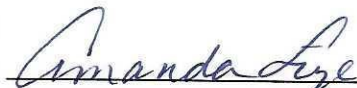
Those presents were: Frances Howard, Will Downing, John Pedigo, Jeremy Jones, Chris Veach Amanda Frye.

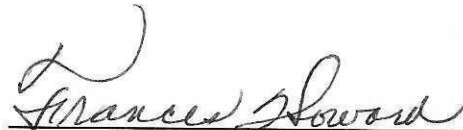

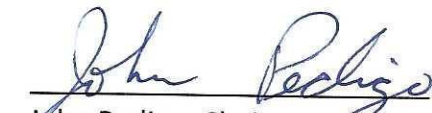
