Fountain Run Water Commissioners met in the Water Office on February 17, 2026 at 6:00 p.m. for a regular meeting.

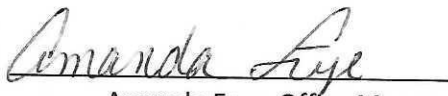

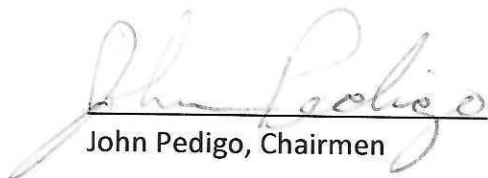
There being no other business, the meeting was adjourned at 7:13 p.m. by a motion from Jeremy Jones and seconded by Will Downing. Motion carried.

Fountain Run Water Commissioners met in the Water Office on June 16, 2026 at 6:00 p.m. for a regular meeting.

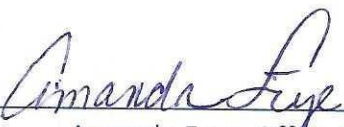
