STATUS UPDATE


Comes, Honorable Wes Stephens and hereby files on behalf of the: Fountain Run Water District #1, its individual commissioners: Francis Howard, Jeremy Jones, John Pedigo, Will Downing, Owen Lambert; and its manager Christopher Veach, individually and collectively, the following status update.

1. The vacant board seat was filled by Owen Lambert pursuant to an appointment from the Barren Fiscal Court and the appropriate paperwork has been filed.
2. The Fountain Run Water District #1 attempted to comply with filing an alternative rate application by the April 30, 2026 deadline. The application was rejected due to the reasons set forth in the attached letter. (Exhibit A)
3. Deficiencies 1 and 2 have been cured by subsequent filings.
4. Deficiency 3 is more problematic.

3. 807 KAR 5:076 Section 4(1) (a) (b) (c) (d) (f): Information for each of the noted subsections of 807 KAR 5:076 Section 4(1) is incorrect due to applicant using incorrect test year. Application uses the 2024 test year. However, the 2025 test year should be used to ensure accuracy of information provided.

5. The Fountain Run Water District #1 only received the first draft of its 2025 financials on April 29, 2026. The Fountain Run Water District #1 is requesting an exemption to use the 2024 financials as they are similar to the 2025 and will not result in a material change to the alternative rate application, or, in the alternative, the Fountain Run Water District #1 is asking for an extension to file using the 2025 financials until June 15, 2026.

Commission Staff has reviewed the application in the above case. This filing is rejected for the reason(s) set forth below.

Filing deficiency pursuant to:

1. 807 KAR 5:076 Section 5(4): The provided notice does not include average usage.
2. 807 KAR 5:076 Section 4(1)(h): Completed ARF Form-3 for each member of board of directors/commissioners, CEO or general manager, ownership of 10% or more; ARF Form-3 is required for each commissioner. However, a form was only provided for the manager.
3. 807 KAR 5:076 Section 4(1) (a) (b) (c) (d) (f): Information for each of the noted subsections of 807 KAR 5:076 Section 4(1) is incorrect due to applicant using incorrect test year. Application uses the 2024 test year. However, the 2025 test year should be used to ensure accuracy of information provided.

The information necessary to cure the deficiency must be submitted within 10 days of the date of this letter.
