JOINT MOTION FOR A DECISION ON THE EXISTING RECORD

Big Rivers Electric Corporation (“*Big Rivers*”), Kenergy Corp. (“*Kenergy*”), Justified DataPower LLC, a subsidiary of TeraWulf Inc. (“*TeraWulf*”), and the Attorney General of the Commonwealth of Kentucky, through his Office of Rate Intervention (the “*Attorney General*”),¹ jointly and respectfully move the Kentucky Public Service Commission (the “*Commission*”) to submit this proceeding for a decision based on the existing record. In support of this Joint Motion, the Parties state:

1. Pursuant to the Commission’s July 10, 2026, Order amending the procedural schedule in the matter, the Parties were directed to file either a request for a hearing or that the case to be submitted for decision based on the record no later than July 28, 2026.

2. The Parties agree that the existing written evidence of record is comprehensive and sufficient to enable the Commission to reach a full and fair determination on all pending issues.

Should the Commission find that the hearing in this matter is necessary, the Parties reserve the right to fully participate in that hearing.

WHEREFORE, the Parties respectfully request that the Commission submit this proceeding for a final decision based on the existing record.
