Inter-County student sees nation's heritage up close

Samuel Fielder represents co-op on 2026 Washington Youth Tour

Samuel Fielder returned from Washington, D.C., with more than memories of historic buildings and famous landmarks. The Garrard County High School senior came home with a clearer sense of citizenship and the role young people can play in the future of their communities and country.

Fielder was sponsored by Inter-County Energy on the Washington Youth Tour, a weeklong experience coordinated by Kentucky Electric Cooperatives and the National Rural Electric Cooperative Association. The program brings together rising young

leaders from electric cooperative communities to experience American history, civic engagement and the cooperative commitment to community.

"The Washington Youth Tour gave me the chance to get a front row seat to our nation's heritage," Fielder says. "I left feeling inspired and hopeful for what we can accomplish together as young Americans."

The Kentucky delegation's week began with visits to Thomas Jefferson's Monticello and George Washington's Mount Vernon before students continued to Washington, D.C.

On Capitol Hill, students were engaged and appreciative of the opportunity to discuss important issues with congressional staff members and U.S. Sen. Rand Paul. They spoke up for electric cooperatives, asking about FEMA reform and how to make sure Kentucky co-ops are adequately served by FEMA. They also asked about artificial intelligence and the nation's future.

The week also included a walking tour of the memorials on the National Mall, stops at the Smithsonian museums, the White House Visitor Center,



the World War I Memorial, the Holocaust Museum and the National Air and Space Museum.

One of the most solemn moments came at Arlington National Cemetery, where the Kentucky students watched the Changing of the Guard and members of the delegation laid a wreath at the Tomb of the Unknown Soldier.

“It is a privilege to spend a week in Washington, D.C., with some of Kentucky’s brightest young leaders,” says Mallory Wafzig, the statewide association’s manager of cooperative outreach. “As they walk in the footsteps of our nation’s founders and experience our republic firsthand, they are inspired to lead, serve and make a difference in their own communities.”

Wafzig thanked the chaperones who helped lead and support the students throughout the week, notably Inter-County Energy’s April and Rudy Burgess.

CORRECTED NOTICE

Inter-County Energy Cooperative Corporation ("Inter-County Energy") intends to propose a new tariff, Farm and Home Service - Schedule 1 - Inclining Block ("IB") by filing the new tariff with the Kentucky Public Service Commission ("Commission") on or after July 1, 2026. Inter-County Energy will request that the new tariff and the new rates associated with the new tariff become effective on or after August 1, 2026.

The new tariff will be a voluntary tariff for members currently served under Farm and Home Service - Rate Schedule 1 ("Schedule 1") that have low usage agricultural buildings; including, barns, dairy barn, garages, gates, grain bins, silos, and water wells/pumps. Members must agree to one-year minimum term to take service under this rate schedule.

Inter-County is only proposing the new tariff and the new rates associated with the new voluntary tariff. There are no existing rates and the proposed rates for the new tariff are set forth below:

MONTHLY RATE

Facility Charge	\$16.16 per month
Energy Charge per kWh	
0-300	\$0.07261
301-500	\$0.11057
Over 500	\$0.13778

Inter-County Energy does not propose revisions to any other tariffs or schedules not listed above.

If the Commission does not receive a written request for intervention within thirty (30) days of initial publication or mailing of this notice, the Commission may take final action on the tariff filing. The new tariff contained in this notice is the tariff and rates proposed by Inter-County Energy, but the Commission may order rates or changes to the tariff that differ from the proposed rates and the tariff contained in this notice.
