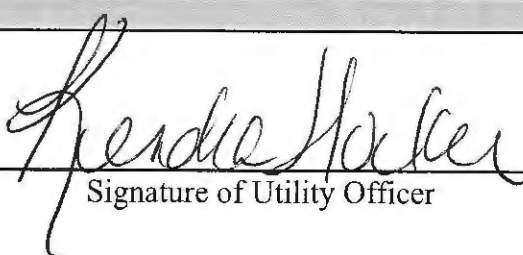

NOTICE:

The City of Stanford ("Stanford") is providing notice that it plans to file with the Public Service Commission, on or before August 13, 2026, to increase its wholesale rate to McKinney Water District effective for water service on and after September 23, 2026. The proposed rates are as follows:

<u>Current Rate</u>	<u>Proposed Rate</u>	<u>\$ Difference</u>	<u>% Difference</u>

Water flowing through the meter(s) before the effective date will be charged at the current rates while water flowing through the meter(s) on and after the effective date will be charged at the new rates.

In accordance with Public Service Commission procedures, the effective date of the new rates cannot be prior to the expiration of a 30-day notice given to both the Commission and McKinney Water District.

This filing may be examined at the offices of Stanford located at 842 East Main Street in Stanford, Kentucky.

The filing may also be examined at the offices of the Public Service Commission located at 211 Sower Boulevard in Frankfort, Kentucky, Monday – Friday from 8:00 am – 4:30 pm or on the PSC website at <http://psc.ky.gov>.

Comments regarding this filing may be submitted by mail to the Public Service Commission, Post Office Box 615, Frankfort, Kentucky 40602; or through its website at <http://psc.ky.gov>.

The new rates are the rates proposed by Stanford in its filing but the Public Service Commission may order rates that differ from the proposed rates.

Intervention may be requested by submitting a timely written request for intervention by mail to the Public Service Commission, Post Office Box 615, Frankfort, Kentucky 40602. The request for intervention must establish the grounds for the request including the status and interest of the party.

If the Public Service Commission does not receive a written request for intervention within thirty (30) days of the providing of this notice, the Public Service Commission may take final action on the filing.

RESOLUTION NO. 2026-09-08

**A RESOLUTION OF MCKINNEY COUNTY WATER DISTRICT
ADJUSTING ITS WATER RATES TO OFFSET CITY OF STANFORDS'
WHOLESALE RATE INCREASE**

WHEREAS, the City of Stanford supplies potable water to McKinney Water District on a wholesale basis;

WHEREAS, on August 13, 2026, the City of Stanford informed McKinney Water District it would be increasing its wholesale rate effective September 23, 2026;

WHEREAS, based upon the water purchases from the City of Stanford during the previous 12 months, the estimated annual increased cost to McKinney Water District will be **\$14,499.61**;

WHEREAS, prudent financial management dictates that McKinney Water District take action to adjust its retail rates commensurate with the City of Stanford's wholesale rate increase; and

WHEREAS, KRS 278.015 and 807 KAR 5:068 provide the legal mechanism for McKinney Water District to increase its water rates to commensurate with the City of Standrord's wholesale rate increase via a Purchased Water Adjustment ("PWA")

NOW, THEREFORE, THE BOARD OF COMMISSIONERS OF MCKINNEY WATER DISTRICT DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. The facts, recitals, and statements contained in the foregoing preamble of this Resolution are true and correct and are hereby affirmed and incorporated as a part of this Resolution.

Section 2. The PWA factor is **\$.13** per 1,000 gallons;

Section 3. All tiers of water usage and the wholesale water rate set forth in McKinney Water District's existing tariff shall be increased by **\$.13** per 1,000 gallons, subject to any minor adjustment that may be made by the PSC.

Section 4. The monthly water rates to be charged to and collected from the customers and users of the water system of McKinney Water District shall be as set forth in **Exhibit C**, which is attached hereto and is incorporated herein by reference as a part of this Resolution. The rates set forth in **Exhibit C** are subject to any minor adjustment that may be made by the PSC. These monthly rates shall be in effect for all water service rendered on and after September 23, 2026, upon PSC approval.

Section 5. The Chairman and the General Manager are hereby authorized and directed to execute and file the PWA Application, Tariff Sheet, and all other documents that may be required by the PSC.

Section 6. The Chairman, General Manager, and all appropriate McKinney Water District Staff are hereby further authorized and directed to take any and all other actions and to execute and deliver any and all other documents as may be reasonably necessary to implement the PWA.

Section 7. This Resolution shall take effect upon its adoption.

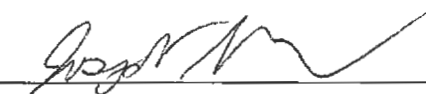
