

**AMENDMENT
TO THE
AGREEMENT BETWEEN
DUKENET COMMUNICATIONS, LLC
AND
BELLSOUTH TELECOMMUNICATIONS, INC.
DATED JULY 25, 2001**

Pursuant to this Amendment, (the "Amendment"), DukeNet Communications, LLC, ("DukeNet"), and BellSouth Telecommunications, Inc. ("BellSouth"), hereinafter referred to collectively as the "Parties," hereby agree to amend that certain Interconnection Agreement between the Parties dated July 25, 2001, (the "Agreement").

WHEREAS, DukeNet and BellSouth entered into the Agreement on July 25, 2001, and;

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

1. DukeNet and BellSouth agree to amend Attachment 4, Exhibit B, to add a virtual Administrative Only Application Fee as set forth in Exhibit A attached hereto and made a part of this Amendment.
2. This Amendment shall be effective thirty (30) days from the date of the last signature executing this Amendment.
4. All of the other provisions of the Agreement, dated July 25, 2001, shall remain in full force and effect.
5. Either or both of the Parties is authorized to submit this Amendment to the respective state regulatory authorities for approval subject to Section 252(e) of the Federal Telecommunications Act of 1996.
