AGREEMENT

This Agreement, which shall become effective thirty (30) days following the date of the last signature of both Parties (Effective Date), is entered into by and between XO Long Distance Services, Inc. (XO Long Distance), a Washington corporation on behalf of itself, and BellSouth Telecommunications, Inc., (BellSouth), a Georgia corporation, having an office at 675 W. Peachtree Street, Atlanta, Georgia, 30375, on behalf of itself and its successors and assigns.

WHEREAS, the Telecommunications Act of 1996 (the "Act") was signed into law on February 8, 1996; and

WHEREAS, section 252(i) of the Act requires BellSouth to make available any interconnection, service, or network element provided under an agreement approved by the appropriate state regulatory body to any other requesting telecommunications carrier upon the same terms and conditions as those provided in the agreement in its entirety; and

WHEREAS, XO Long Distance has requested that BellSouth make available the interconnection agreement in its entirety executed between BellSouth and Network Telephone Corporation dated June 20, 2003 for the state(s) of Alabama, Kentucky, Louisiana and South Carolina.

NOW, THEREFORE, in consideration of the promises and mutual covenants of this Agreement, XO Long Distance and BellSouth hereby agree as follows:

1. XO Long Distance and BellSouth shall adopt in its entirety the Network Telephone Corporation Interconnection Agreement dated June 20, 2003 and any and all amendments to said agreement executed and approved by the appropriate state regulatory commission as of the date of the execution of this Agreement. The Network Telephone Corporation Interconnection Agreement and all amendments are attached hereto as Exhibit 1 and incorporated herein by this reference.
