

**Amendment to the Agreement
Between
AmeriMex Communications Corp.
and
BellSouth Telecommunications, Inc.
Dated September 22, 2005**

Pursuant to this Amendment, (the "Amendment"), AmeriMex Communications Corp. (AmeriMex), and BellSouth Telecommunications, Inc. (BellSouth), hereinafter referred to collectively as the "Parties," hereby agree to amend that certain Interconnection Agreement between the Parties dated September 22, 2005 (Agreement) to be effective thirty (30) calendar days after the date of the last signature executing the Amendment (Effective Date).

WHEREAS, BellSouth and AmeriMex entered into the Agreement on September 22, 2005, and;

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

1. The Parties agree to delete and replace the Regional Operations Support Systems (OSS) rates in Exhibit D of Attachment 1 for all states and incorporate the State OSS rates set forth in Exhibit 1, attached hereto and incorporated herein by this reference.
2. The Parties agree to delete and replace the Regional Operations Support Systems (OSS) rates in Exhibit A of Attachment 2 for all states and incorporate the State OSS rates set forth in Exhibit 2, attached hereto and incorporated herein by this reference.
3. All of the other provisions of the Agreement, dated September 22, 2005, shall remain in full force and effect.
4. Either or both of the Parties are authorized to submit this Amendment to the respective state regulatory authorities for approval subject to Section 252(e) of the Federal Telecommunications Act of 1996.
