

**Amendment to the Agreement  
Between  
Xspedius Communications, LLC  
and  
BellSouth Telecommunications, Inc.  
Dated December 30, 2002**

Pursuant to this Amendment, (the "Amendment"), Xspedius Communications, LLC (Xspedius), and BellSouth Telecommunications, Inc. (BellSouth), hereinafter referred to collectively as the "Parties," hereby agree to amend that certain Interconnection Agreement between the Parties dated December 30, 2002 (Agreement) to be effective on the date of the last signature executing the Amendment (Effective Date).

WHEREAS, BellSouth and Xspedius entered into the Agreement on December 30, 2002;

WHEREAS, BellSouth and Xspedius Communications Co. Switched Services, LLC and Xspedius Communications Co. Jacksonville, LLC entered into separate Interconnection Agreements on March 11, 2006 for the states of Florida and North Carolina;

WHEREAS, this Amendment applies to the States of Alabama, Georgia, Kentucky, Louisiana, Mississippi, South Carolina and Tennessee, and;

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:
