Local Service Exchange Areas Between Which Extended Area Service (EAS) Traffic Is To Be Exchanged Pursuant to this Agreement.

This Exhibit specifies the Local Service Exchange Areas, Extended Area Services, interconnection facilities, and interconnection point(s) pursuant to the AGREEMENT FOR THE TRANSPORT AND TERMINATION OF EXTENDED AREA SERVICE (EAS) TRAFFIC between West Kentucky Rural Telephone Cooperative Corporation, Inc. ("WKRT Cooperative") and Cinergy Communications Company ("CCC") as follows:

I. Local Service Areas Covered by this Agreement:

1. The Hardin Local Service Exchange Area is the geographic area covering the Hardin exchange as operated by WKRT Cooperative on January 1, 1998 ("Hardin") with a V&H of V=7020 and H=3008.
2. The Fairdealing Local Service Exchange Area is the geographic area covering the Fairdealing exchange as operated by WKRT Cooperative on January 1, 1998 ("Fairdealing") with a V&H of V=6998 and H= 3006.
3. The Benton Local Service Exchange Area is the geographic area covering the Benton exchange as operated by BellSouth Communications, Inc. on January 1, 1998 ("Benton") with a V&H of V=7006 and H=3025.
4. The Sedalia Local Service Exchange Area is the geographic area covering the Sedalia exchange as operated by WKRT Cooperative on January 1, 1998 ("Sedalia") with a V&H of V=7067 and H=3043.
5. The Farmington Local Service Exchange Area is the geographic area covering the Farmington exchange as operated by WKRT Cooperative on January 1, 1998 ("Farmington") with a V&H of V=7056 and H=3034.
6. The Wingo Local Service Exchange Area is the geographic area covering the Wingo exchange as operated by WKRT Cooperative on January 1, 1998 ("Wingo") with a V&H of V=7077 and H=3065.
7. The Lynnville Local Service Exchange Area is the geographic area covering the Lynnville exchange as operated by WKRT Cooperative on January 1, 1998 ("Lynnville") with a V&H of V=7080 and H=3030.
8. The Fancy Farm Local Service Exchange Area is the geographic area covering the Fancy Farm exchange as operated by WKRT Cooperative on January 1, 1998 ("Fancy Farm") with a V&H of V=7052 and H=3088.
9. The Lowes Local Service Exchange Area is the geographic area covering the Lowes exchange as operated by WKRT Cooperative on January 1, 1998 ("Lowes") with a V&H of V=7034 and H=3094.

10. The Folsomdale Local Service Exchange Area is the geographic area covering the Folsomdale exchange as operated by WKRT Cooperative on January 1, 1998 ("Folsomdale") with a V&H of V=7025 and H=3079.

11. The West Plains Local Service Exchange Area is the geographic area covering the West Plains exchange as operated by WKRT Cooperative on January 1, 1998 ("West Plains") with a V&H of V=7034 and H=3059.

12. The Mayfield Local Service Exchange Area is the geographic area covering the Mayfield exchange as operated by BellSouth Communications, Inc. on January 1, 1998 ("Mayfield") with a V&H of V=7051 and H=3058.

13. The Lynn Grove Local Service Exchange Area is the geographic area covering the Lynn Grove exchange as operated by WKRT Cooperative on January 1, 1998 ("Lynn Grove") with a V&H of V=7063 and H=3013.

14. The New Concord Local Service Exchange Area is the geographic area covering the New Concord exchange as operated by WKRT Cooperative on January 1, 1998 ("New Concord") with a V&H of V=7038 and H=2968.

15. The Kirksey Local Service Exchange Area is the geographic area covering the Kirksey exchange as operated by WKRT Cooperative on January 1, 1998 ("Kirksey") with a V&H of V=7040 and H=3017.

16. The Hazel Local Service Exchange Area is the geographic area covering the Hazel exchange as operated by WKRT Cooperative on January 1, 1998 ("Hazel") with a V&H of V=7072 and H=2986.

17. The Murray Local Service Exchange Area is the geographic area covering the Murray exchange as operated by BellSouth Communications, Inc. on January 1, 1998 ("Murray") with a V&H of V=7049 and H=2994.

II. Extended Area Service Traffic Covered by this Agreement includes:

1. Hardin-Benton EAS traffic includes calls that originate in Hardin (from WKRT Cooperative NPA-NXX of 270-437) and terminate in Benton (to CCC NPA-NXX of 270-460) and calls that originate in Benton (from Cinergy NPA-NXX of 270-460) and terminate in Hardin (to WKRT Cooperative NPA-NXX of 270-437).

2. Fairdealing-Benton EAS traffic includes calls that originate in Fairdealing (from WKRT Cooperative NPA-NXX of 270-354) and terminate in Benton (to CCC NPA-NXX of 270-460) and calls that originate in Benton (from Cinergy NPA-NXX of 270-460) and terminate in Fairdealing (to WKRT Cooperative NPA-NXX of 270-354).

3. Sedalia-Mayfield EAS traffic includes calls that originate in Sedalia (from WKRT Cooperative NPA-NXX of 270-328) and terminate in Mayfield (to CCC NPA-NXX of 270-

650) and calls that originate in Mayfield (from Cinergy NPA-NXX of 270-650) and terminate in Sedalia (to WKRT Cooperative NPA-NXX of 270-328).

4. Farmington-Mayfield EAS traffic includes calls that originate in Farmington (from WKRT Cooperative NPA-NXX of 270-345) and terminate in Mayfield (to CCC NPA-NXX of 270-650) and calls that originate in Mayfield (from Cinergy NPA-NXX of 270-650) and terminate in Farmington (to WKRT Cooperative NPA-NXX of 270-345).
5. Wingo-Mayfield EAS traffic includes calls that originate in Wingo (from WKRT Cooperative NPA-NXX of 270-376) and terminate in Mayfield (to CCC NPA-NXX of 270-650) and calls that originate in Mayfield (from Cinergy NPA-NXX of 270-650) and terminate in Wingo (to WKRT Cooperative NPA-NXX of 270-376).
6. Lynnville-Mayfield EAS traffic includes calls that originate in Lynnville (from WKRT Cooperative NPA-NXX of 270-382) and terminate in Mayfield (to CCC NPA-NXX of 270-650) and calls that originate in Mayfield (from Cinergy NPA-NXX of 270-650) and terminate in Lynnville (to WKRT Cooperative NPA-NXX of 270-382).
7. Fancy Farm-Mayfield EAS traffic includes calls that originate in Fancy Farm (from WKRT Cooperative NPA-NXX of 270-623) and terminate in Mayfield (to CCC NPA-NXX of 270-650) and calls that originate in Mayfield (from Cinergy NPA-NXX of 270-650) and terminate in Fancy Farm (to WKRT Cooperative NPA-NXX of 270-623).
8. Lowes-Mayfield EAS traffic includes calls that originate in Lowes (from WKRT Cooperative NPA-NXX of 270-674) and terminate in Mayfield (to CCC NPA-NXX of 270-650) and calls that originate in Mayfield (from Cinergy NPA-NXX of 270-650) and terminate in Lowes (to WKRT Cooperative NPA-NXX of 270-674).
9. Folsomdale-Mayfield EAS traffic includes calls that originate in Folsomdale (from WKRT Cooperative NPA-NXX of 270-856) and terminate in Mayfield (to CCC NPA-NXX of 270-650) and calls that originate in Mayfield (from Cinergy NPA-NXX of 270-650) and terminate in Folsomdale (to WKRT Cooperative NPA-NXX of 270-856).
10. West Plains-Mayfield EAS traffic includes calls that originate in West Plains (from WKRT Cooperative NPA-NXX of 270-658) and terminate in Mayfield (to CCC NPA-NXX of 270-650) and calls that originate in Mayfield (from Cinergy NPA-NXX of 270-650) and terminate in West Plains (to WKRT Cooperative NPA-NXX of 270-658).
11. Lynn Grove-Murray EAS traffic includes calls that originate in Lynn Grove (from WKRT Cooperative NPA-NXX of 270-435) and terminate in Murray (to CCC NPA-NXX of 270-661) and calls that originate in Murray (from Cinergy NPA-NXX of 270-661) and terminate in Lynn Grove (to WKRT Cooperative NPA-NXX of 270-435).
12. New Concord-Murray EAS traffic includes calls that originate in New Concord (from WKRT Cooperative NPA-NXX of 270-436) and terminate in Murray (to CCC NPA-NXX of 270-661) and calls that originate in Murray (from Cinergy NPA-NXX of 270-661) and terminate in New Concord (to WKRT Cooperative NPA-NXX of 270-436).
13. Hardin-Murray EAS traffic includes calls that originate in Hardin (from WKRT Cooperative NPA-NXX of 270-437) and terminate in Murray (to CCC NPA-NXX of 270-661) and calls that originate in Murray (from Cinergy NPA-NXX of 270-661) and terminate in Hardin (to WKRT Cooperative NPA-NXX of 270-437).

14. Kirksey-Murray EAS traffic includes calls that originate in Kirksey (from WKRT Cooperative NPA-NXX of 270-489) and terminate in Murray (to CCC NPA-NXX of 270-661) and calls that originate in Murray (from Cinergy NPA-NXX of 270-661) and terminate in Kirksey (to WKRT Cooperative NPA-NXX of 270-489).

15. Hazel-Murray EAS traffic includes calls that originate in Hazel (from WKRT Cooperative NPA-NXX of 270-492) and terminate in Murray (to CCC NPA-NXX of 270-661) and calls that originate in Murray (from Cinergy NPA-NXX of 270-661) and terminate in Hazel (to WKRT Cooperative NPA-NXX of 270-492).

III. Designation of Points of Connection For the Delivery of EAS Traffic Pursuant to this Agreement:

1. Point of Connection between the Parties. For Sedalia-Mayfield EAS, Farmington-Mayfield EAS, Wingo-Mayfield EAS, Lynnville-Mayfield EAS, Fancy Farm-Mayfield EAS, Lowes-Mayfield EAS, Folsomdale-Mayfield EAS, West Plains-Mayfield EAS, Hardin-Murray EAS, Hardin-Benton EAS, New Concord-Murray EAS, Hazel-Murray EAS, Lynn Grove-Murray EAS, Kirksey-Murray EAS, and Fairdealing-Benton EAS traffic, the Parties agree to connect their respective facilities at Pedestal LA2/13F (located at Latitude North 36 Degrees, 55 Minutes, 15.5 Seconds; Longitude West 88 Degrees, 41 Minutes, 9 Sseconds) located in the Folsomdale exchange of WKRT (V=7025, H=3079) with WKRT using Lucent DDM 2000 electronics. CCC may utilize the facilities of a third party network facilities provider to establish the interconnection point for CCC between the networks of WKRT and CCC at this interconnection point, and for the purposes of this Agreement, the specified third party facilities are considered to be the facilities of CCC.

2. CCC may appoint a third party network facilities provider agent for the sole purpose of establishing, provisioning, maintaining and administering the facilities to the Point of Interconnection as set forth in Section III, 1 above. CCC shall provide separate written notice of its appointment of a third party network facilities provider agent. The authority granted to CCC's agent pursuant to the Agreement and this Exhibit 1 is limited to interconnection with the public switched telephone network under the terms and conditions of the AGREEMENT FOR THE TRANSPORT AND TERMINATION OF EXTENDED AREA SERVICE (EAS) TRAFFIC between WKRT and CCC and the interconnection shall not be used for any other purpose. CCC agrees that WKRT will rely on this authorization until otherwise notified in writing by CCC. CCC specifically confirms that it is responsible for its agent(s) and bound by the acts or omissions of its agent(s) to the extent CCC's agent(s) acts on CCC's behalf as outlined above. CCC specifically confirms that it is responsible for any and all costs associated with the utilization of a third party facilities for all traffic exchanged under this Agreement. The appointment of this agent by CCC does not relieve CCC of any of the obligations undertaken pursuant to the AGREEMENT FOR THE TRANSPORT AND TERMINATION OF EXTENDED AREA SERVICE (EAS) TRAFFIC between WKRT and CCC.

3. CCC must provide ten (10) days' written notice to West Kentucky of the agent's appointment. Such notice shall include the name of the specific authorized individual(s) within the agent's organization. CCC may only modify its agent appointment by providing ten (10) days' prior written notice to West Kentucky. In the case of a new agent appointment, CCC shall provide notice of the name of the specific authorized individual(s) and company. In the case of the removal of an existing agent, CCC shall provide the name of the individual(s).






RE: Letter of Authorization Cinergy Communications Company Designation of Agent

This letter authorizes David Dobbs, and David Triplett of Kentucky Data Link to act as agent on behalf of Cinergy Communications Company (CCC) for the purposes of provisioning facilities under the AGREEMENT FOR THE TRANSPORT AND TERMINATION OF EXTENDED AREA SERVICE (EAS) TRAFFIC between West Kentucky Rural Telephone Cooperative Corporation, Inc. (West Kentucky) and CCC. The authority granted to Kentucky Data Link pursuant to this letter is limited to the provisioning of facilities on behalf of CCC as set forth in Exhibit 1, Section III to the AGREEMENT FOR THE TRANSPORT AND TERMINATION OF EXTENDED AREA SERVICE (EAS) TRAFFIC between West Kentucky and CCC. West Kentucky is permitted to rely on this authorization until otherwise notified in writing by CCC. CCC specifically confirms that it is bound by the acts or omissions of its agents.

The appointment of the agent by CCC does not relieve CCC of the obligations undertaken pursuant to the AGREEMENT FOR THE TRANSPORT AND TERMINATION OF EXTENDED AREA SERVICE (EAS) TRAFFIC between West Kentucky and CCC. The agency arrangement is intended merely to accommodate CCC's use of facilities of Kentucky Data Link for purposes of establishing the Point of Connection between CCC and West Kentucky for the exchange of traffic contemplated by the AGREEMENT FOR THE TRANSPORT AND TERMINATION OF EXTENDED AREA SERVICE (EAS) TRAFFIC between West Kentucky CCC


CCC may only modify its agent appointment by providing ten (10) days prior written notice to West Kentucky. In the case of a new agent appointment, CCC shall provide notice of the name of the specific authorized individual(s) and company. In the case of the removal of an existing agent, CCC shall provide the name of the individual(s).
