Dear Scott and Jim:

As you know, Xspedius Communications, LLC ("Xspedius"), as of April 6, 2005, purchased and owns the assets of ICG Communications, Inc. (including its subsidiary ICG Telecom Group, Inc.) (collectively "ICG") in Alabama, Georgia, Kentucky, North Carolina, and South Carolina. I am writing in connection with that transaction.

I have attached hereto an Attachment A listing all the circuits that ICG had with ALLTEL that are now owned by Xspedius and an Attachment B listing all the billing account numbers (BANs) that ICG had with ALLTEL that are now owned by Xspedius. Pursuant to the asset purchase agreement between Xspedius and ICG, ICG is responsible for all charges on these circuits and BANs through April 5, 2005 but not thereafter; Xspedius is responsible for all charges on these circuits and BANs beginning April 6, 2005, but not before that date.


ICG is assigning four of its five interconnection agreements with ALLTEL to Xspedius, namely the agreements with ALLTEL Alabama, ALLTEL Kentucky, ALLTEL Carolina, and ALLTEL Georgia Communications Corporation, ALLTEL Georgia, Inc., ALLTEL Georgia Telephone Corporation, Georgia ALLTEL Telecom, Inc. and Standard Telephone Company (collectively ALLTEL Georgia). ICG has a fifth one with Kentucky ALLTEL covering the former GTE territory in Lexington, Kentucky but it is not necessary for Xspedius to have that agreement assigned to it because Xspedius already has an agreement in place for that area.

Xspedius, ICG, and ALLTEL, by signing below, each agree to the above assignment of the referenced circuits, BANs and interconnection agreements. Please execute three copies of this letter and send one original each to the other parties so that we will each have copies.

Thank you for your attention to this matter.


