AGREEMENT

This Agreement, which shall become effective thirty (30) days following the date of the last signature of both Parties ("Effective Date"), is entered into by and between Epicus Communications Group, Inc. WHEREAS, section 252(i) of the Act requires BellSouth to make available any interconnection, service, or network element provided under an agreement approved by the appropriate state regulatory body to any other requesting telecommunications carrier upon the same terms and conditions as those provided in the agreement in its entirety; and

WHEREAS, Epicus has requested that BellSouth make available the interconnection agreement in its entirety executed between BellSouth and 1-800-RECONEX, Inc. d/b/a USTEL dated November 10, 2005 for the state(s) of Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina and Tennessee.

NOW, THEREFORE, in consideration of the promises and mutual covenants of this Agreement, Epicus and BellSouth hereby agree as follows:

1. Epicus and BellSouth shall adopt in its entirety the 1-800-RECONEX, Inc. d/b/a USTEL Interconnection Agreement dated November 10, 2005 and any and all amendments to said agreement executed and approved by the appropriate state regulatory commission as of the date of the execution of this Agreement. The 1-800-RECONEX, Inc. d/b/a USTEL Interconnection Agreement and all amendments are attached hereto as Exhibit 1 and incorporated herein by this reference.
