# **AMENDMENT NO. 2**

This Amendment No. 2 ( "Amendment") is made this 23rd day of August, 2010 ("Amendment Effective Date"), by and between Windstream Kentucky, East, LLC ("Windstream"), with its principal place of business at 4001 Rodney Parham Rd., Little Rock, Arkansas 72212 and SouthEast Telephone, Inc. ("SouthEast") (Windstream and SouthEast may be hereinafter referred to, each individually, as a "Party" and, collectively, as the "Parties").

This Amendment covers services in the Commonwealth of Kentucky.

#### WITNESSETH:

WHEREAS, SouthEast and Windstream are Parties to an Interconnection Agreement entered into pursuant to Sections 251 and 252 of the Telecommunications Act of 1996, that was approved by the Kentucky Public Service Commission in PSC Reference No. 00903 (the "Agreement"); and

WHEREAS, SouthEast and Windstream amended the Interconnection Agreement effective July 9, 2008; and

WHEREAS, the amended Agreement is set to expire by its own terms on October 31, 2010; and

**NOW, THEREFORE**, in consideration of the mutual promises, provisions and covenants herein contained, the sufficiency of which is hereby acknowledged, the Parties agree as follows:

# 1.0 <u>Section 4.1 of the General Terms and Conditions is replaced in its entirety with the following:</u>

4.1 The Parties agree to the provisions of this Agreement for a term of fifty-four (54) months ("the Term") from the Effective Date of this Agreement. This Agreement will terminate on October 31, 2011 ("the Termination Date").

# PUBLIC SERVICE COMMISSION

#### **Miscellaneous Provisions are amended as follows:** 2.0

- Conflict between this Amendment and the Agreement. This Amendment shall be 2.1 deemed to revise the terms and provisions of the Agreement to the extent necessary to give effect to the terms and provisions of this Amendment. In the event of a conflict between the terms and provisions of this Amendment and the terms and provisions of the Agreement, this Amendment shall govern, provided, however, that the fact that a term or provision appears in this Amendment but not in the Agreement, or in the Agreement but not in this Amendment, shall not be interpreted as, or deemed grounds for finding, a conflict for purposes of this Section 2.
- 2.2 Counterparts. This Amendment may be executed in one or more counterparts, each of which when so executed and delivered shall be an original and all of which together shall constitute one and the same instrument.
- 2.3 Captions. The Parties acknowledge that the captions in this Amendment have been inserted solely for convenience of reference and in no way define or limit the scope or substance of any term or provision of this Amendment.
- Scope of Amendment. This Amendment shall amend, modify and revise the 2.4 Agreement only to the extent set forth expressly in Section 1 of this Amendment, and, except to the extent set forth in Section 1 of this Amendment, the terms and provisions of the Agreement shall remain in full force and effect after the Effective Date.
