INTERCONNECTION AGREEMENT BETWEEN MCC TELEPHONY OF THE SOUTH, LLC

AND

LOGAN TELEPHONE COOPERATIVE CORPORATION, INC. FOR THE STATE OF KENTUCKY

This Agreement (the "Agreement") is made by and between MCC Telephony of the South, LLC, a Delaware Limited Liability Company ("MCC"), and Logan Telephone Cooperative Corporation, Inc. ("Logan Telephone") (MCC and Logan Telephone hereinafter collectively referred to as the "Parties" and each individually as a "Party").

NOW, THEREFORE, for and in consideration of the mutual promises and covenants contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, MCC and Logan Telephone hereby covenant and agree as follows:

- 1. Pursuant to Section 252(i) of the Communications Act of 1934, as amended by the Telecommunications Act of 1996 (the "Act"), this Agreement hereby incorporates by reference, in their entirety, the rates, terms and conditions of that certain Interconnection Agreement effective September 24, 2007 by and between Logan Telephone and Sprint Communications Company, L.P. ("Sprint") and any and all existing amendments to said Interconnection Agreement as of the date of the execution of this Agreement, as approved by the Kentucky Public Service Commission (the "Logan Telephone/Sprint Agreement") (attached hereto as Exhibit "A"), subject to the following:
 - (a) All references in the Logan Telephone/Sprint Agreement to "Sprint" are deemed to be references to MCC;
 - (b) All notices provided to Logan Telephone under this Agreement shall be provided to the addresses set forth in the Logan Telephone/Sprint Agreement. All notices provided to MCC under this Agreement shall be provided to:

- (c) This Agreement shall be deemed effective as of the date approved by the Public Service Commission of the Commonwealth of Kentucky; and
- (d) The term of this Agreement for said state shall be for the period commencing with the Effective Date and shall expire as set forth in the General Terms and Conditions in Section 3.1 of the Logan Telephone/Sprint Agreement.
- (e) The NXX table contained in Section A ("Designation of the IP(s)") of Appendix A to the Logan Telephone/Sprint Agreement shall be modified as follows:

Logan Telephone Exchange NXX	MCC NXX
Logansport 728-2	Logansport TBD

2. The Parties further agree that Logan Telephone shall submit this Agreement to the Kentucky Public Service Commission for approval pursuant to Section 252(e) of the Act.
