**INTERCONNECTION AGREEMENT UNDER SECTIONS 251 AND 252
OF THE TELECOMMUNICATIONS ACT OF 1996**

by and between

CINCINNATI BELL TELEPHONE COMPANY LLC

and

**TIME WARNER CABLE INFORMATION SERVICES (KENTUCKY), LLC D/B/A
TIME WARNER CABLE**

for

KENTUCKY

This Interconnection Agreement, under Sections 251 and 252 of the Telecommunications Act of 1996 (“**Agreement**”), is made by and between Cincinnati Bell Telephone Company LLC, an Ohio limited liability company with offices at 221 E. Fourth Street, Cincinnati, Ohio 45202 (“**CBT**”), and Time Warner Cable Information Services (Kentucky), LLC d/b/a Time Warner Cable, a Delaware limited liability company, with offices at 60 Columbus Circle, New York, NY 10023 (“**TWCIS (KY)**”).

RECITALS

A. CBT is an Incumbent Local Exchange Carrier and is party to an existing interconnection agreement with **Insight Phone of Kentucky, LLC** (“**Insight Agreement**”), which was filed with the Public Service Commission of Kentucky (“**Commission**”) on October 26, 2005 - PSC Reference No. 00797.

B. TWCIS (KY) has requested to adopt the terms and conditions of the Insight Agreement pursuant to 47 U.S.C. § 252(i).

NOW, THEREFORE, CBT and TWCIS (KY) agree as follows:

1. The terms and conditions of this Interconnection Agreement shall be identical to those of the Insight Agreement, a copy of which is attached hereto and incorporated herein as if fully restated, except that:

- a. Section 31.10 is modified to provide that notices to CLEC shall be provided to:
