

**AMENDMENT
TO THE
AGREEMENT BETWEEN
GS COMMUNICATIONS, INC. AND
BELL SOUTH TELECOMMUNICATIONS, INC.
DATED MAY 18, 1999**

Pursuant to this Agreement, (the "Amendment") GS Communications, Inc. ("GS Communications") and BellSouth Telecommunications, Inc. ("BellSouth"), hereinafter referred to collectively as the "Parties," hereby agree to amend that certain Agreement between the Parties dated May 18, 1999 ("Agreement").

NOW THEREFORE, in consideration of the mutual promises and covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

1. To delete the preamble of the General Terms and Conditions of the Parties May 18, 1999 Resale Agreement in its entirety and replace it with the following:

THIS AGREEMENT is made by and between BellSouth Telecommunications, Inc., ("BellSouth"), a Georgia corporation, and GS Communications, Inc. d/b/a Beep "N" Talk, a Illinois corporation, and shall be deemed effective as of May 18, 1999. This agreement may refer to either BellSouth or Beep "N" Talk.

2. The Parties further agree to replace all references to GS Communications with Beep "N" Talk throughout the entire agreement.
3. All of the other provisions of the Agreement, dated May 18, 1999, shall remain in full force and effect.
4. Either or both of the Parties is authorized to submit this Amendment to each Public Service Commission for approval subject to Section 252(e) of the Federal Telecommunications Act of 1996.
