ORDER

On August 31, 2026, New Cingular Wireless PCS, LLC d/b/a AT&T Mobility (AT&T Mobility) filed a petition, pursuant to 807 KAR 5:001, Section 13, and KRS 61.878, requesting that the Commission grant confidential treatment for ten years for Attachments A-1 and A-2 to AT&T Mobility's eligible telecommunications carrier certification and report.¹

In support of its petition, AT&T Mobility argued that Attachments A-1 and A-2 are entirely comprised of confidential and proprietary information, including AT&T Mobility's network infrastructure, proposed service improvements, build out plans, and operating costs, that are exempt from inspection.² AT&T Mobility also argued that if disclosed, the information would provide competitors and potential competitors with important proprietary information about AT&T Mobility and its operations, which competitors would be unable to obtain otherwise.³

Having considered the petition and the material at issue, the Commission finds that Attachments A-1 and A-2 to AT&T Mobility's eligible telecommunications carrier certification and report are generally recognized as confidential or proprietary; which if publicly disclosed, AT&T Mobility may be unfairly disadvantaged in the commercial marketplace. It therefore meets the criteria for confidential treatment and should be exempted from public disclosure pursuant to 807 KAR 5:001, Section 13, and KRS 61.878(1)(c)(1). .

IT IS THEREFORE ORDERED that:

1. AT&T Mobility's August 31, 2026 petition for confidential treatment is granted.
2. The designated material granted confidential treatment by this Order shall not be placed in the public record or made available for public inspection for ten years or until further order of this Commission.
3. Use of the designated material granted confidential treatment by this Order in any Commission proceeding shall comply with 807 KAR 5:001, Section 13(9).
4. If the designated material granted confidential treatment by this Order becomes publicly available or no longer qualifies for confidential treatment, AT&T Mobility shall inform the Commission and file with the Commission an unredacted copy of the designated material.
5. If a nonparty to this proceeding requests to inspect the material granted confidential treatment by this Order and the period during which the material has been granted confidential treatment has not expired, AT&T Mobility shall have 20 days from receipt of written notice of the request to demonstrate that the material still falls within the

exclusions from disclosure requirements established in KRS 61.878. If AT&T Mobility is unable to make such demonstration, the requested material shall be made available for inspection. Otherwise, the Commission shall deny the request for inspection.

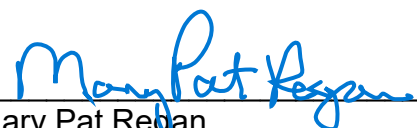
6. The Commission shall not make the requested material available for inspection for 30 days from the date of service of an Order finding that the material no longer qualifies for confidential treatment in order to allow AT&T Mobility to seek a remedy afforded by law.

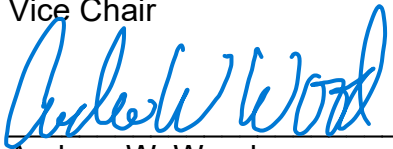

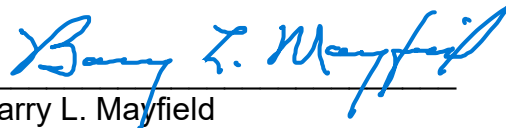
