O R D E R

On December 8, 2008, Windstream Kentucky East, Inc. ("Windstream East") moved for dismissal of the current action. On December 22, 2008, the intervenors, NuVox Communications, Inc., Sprint Communications Company, L.P., Sprint Spectrum, L.P., SprintCom, Inc. d/b/a Sprint PCS, Nextel West Corp. Inc. and NPCR, Inc., d/b/a Nextel Partners ("Sprint Nextel"), tw telecom of ky, llc, and T-Mobile USA, Inc., Powertel/Memphis, Inc., T-Mobile Central LLC (collectively, "Intervenors") submitted their response in opposition to dismissal. On December 23, 2008, the complainants, Brandenburg Telephone Company, Duo County Telephone Cooperative Corporation,

Inc., Highland Telephone Cooperative, Inc., Mountain Rural Telephone Cooperative Corporation, Inc., North Central Telephone Cooperative Corporation, South Central Rural Telephone Cooperative Corporation, Inc., and West Kentucky Rural Telephone Cooperative Corporation, Inc., collectively rural local exchange carriers ("RLECs"), also submitted their response in opposition to the motion.

To ensure that all parties have an adequate and equal opportunity to place their arguments into the record regarding Windstream's motion to dismiss, the Commission will allow Windstream to submit its replies to the responses no later than January 9, 2009 and the RLECs and Intervenors will be allowed to submit their sur-replies no later than January 14, 2009. After that date, the motion will stand submitted for Commission decision.

IT IS HEREBY ORDERED that:

1. Windstream shall submit replies to the RLECs' response and the Intervenors' response no later than January 9, 2009.
2. The RLECs and the Intervenors shall submit sur-replies no later than January 14, 2009.
