

Dear Mr. Buford:

Northern Kentucky Water District provides this response to your letter of April 2. The letter indicates that certain information related to the issuance of bonds, notes or other indebtedness was not provided in the application. As described in paragraph 13(e) of the application, the financing of the project is with Bond Anticipation Notes (BANS), which do not need approval, KIA funds, and other contributions. Those sources of funds are detailed in Exhibit F of the application. The application contains no request for approval of bonds, notes or other indebtedness required of KRS 278.300. The financing that is subject to approval is the proposed surcharge, therefore, the list of deficient items is not applicable to this application.


Item 2 of your letter indicates that the affidavit of a utility officer is not provided. The affidavit of Jack Bragg, Vice President – Finance for NKWD is included in Exhibit D of the application.

Because the items in the letter are either not related to the application or have been provided with the application, NKWD requests that the application be considered filed as of the date of initial submission.
